

## **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

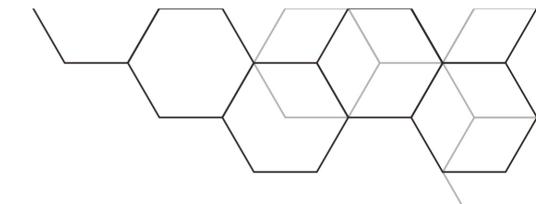
Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



In respect of Appendix 7F Alford – remove site OP5 land at Wellheads, East of Castle Road

#### Reason for change:

The site OP5 originally came into being through modifications recommended by the Reporters to the last LDP. There were no indications at the time that adequate consideration was given to the impact that this allocation would have on the setting of Balfluig Castle. It fundamentally alters the character of the connection between Alford and Balfluig. Castle Road had originally been a road through agricultural land to Alford. It has now been developed by settlement expansions to the west of the road and the further development of OP5 would mean that it would become part of the settlement of Alford. This would fundamentally alter the relationship between the Castle and the settlement. Furthermore, whilst planting is proposed, an inspection of the existing landscape mitigation provided for the existing developments which have expanded Alford to the south shows that the landscape mitigation has been poor. Simply put, there are token landscape strips to the south, but no attempts have been made to provide a robust landscape framework to the southern and eastern boundaries of Alford. These factors have helped to erode the wider landscape setting of Balfluig. OP5 should, therefore, be deleted from the proposed Plan.
