

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Appendix 7e Settlement Statements Kincardine and Mearns, Chapelton, p645, Vision

Inclusion of line at end of second paragraph stating that Chapelton is along with Blairs to be the focus for significant development in the North Kincardine Rural area for the duration of the plan.

**Reason for change:**

To reinforce the aligned views variously expressed by Aberdeenshire planning officers, Aberdeenshire Council Kincardine and Mearns Area Committee, Aberdeenshire Councillors and North Kincardine Rural Community Council that major development within the ward boundaries should currently (and through the life of the new LDP) be constrained between the existing developments at Chapelton and Blairs. The argument in supporting this position being jointly to retain the rural character of the ward by limiting large scale development to a small number of sites whilst helping to support timely delivery at the Chapelton and Blairs Opportunity Sites which have both been impacted by the 2014/15 economic downturn in the oil and gas industry and which could be further impacted during the life of the new LDP by the recent industry downturn. It is my understanding that the required share of the Aberdeenshire housing allocation within the ward can be accommodated between these two Opportunity Sites along with other small scale development that wouldn't be specifically identified in the LDP. Introduction of addition large scale Opportunity Sites could limit the pace of delivery of all sites and where creation of infrastructure and services is conditional on meeting build out targets this would negatively impact on residents. Multiple, dispersed large scale development sites will also likely place significant pressure on the limited infrastructure (roads etc.) and services (primary school provision) of this rural ward and have a negative impact overall.
