

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Objection of extension until 2030 of building warrant for Land North of Braehead, Keig (known as Wealthyton Way, AB33 8DZ)

Reason for change:

The development has been ongoing for an exceptional period of time (at least 16 years) the most recent house being completed in the summer of 2019. This leaves 3 plots still to be developed.

When the developer's company went into liquidation he did come back to the site to remove machinery, some building materials etc but it was left in an extremely untidy state leaving the existing residents living next to and looking out at an unkempt building site for several years. During this time a few of the residents spent several weekends clearing up the mess only to have the developer come back in 2018 to build the one house then disappear again last year leaving the site even more of an eyesore than before. It resembles an abandoned builder's yard more than a building site.

We have no objection to the remaining homes being built but what we do object to is the thought of having to live next to this mess for another 10 years and would like to see either a reduction in the time allocated to complete the development or some way of enforcing the developer to tidy up the site.
