PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Appendix 8 Successful placemaking design guidance (p. 875)

A further element needs to be added to the six qualities listed that make a successful place. The missing element concerns the management of environmental noise and its effects. There is a need to reduce noise pollution where it is excessive (or where it will increase due to new developments) and to preserve environmental noise quality where it is good.

Reason for change:

Noise mapping will enable Aberdeenshire Council to recognise where and when residents are exposed to unacceptable levels of environmental noise from traffic on major roads, railways and from aircraft.

The ALDP mentions noise as a potential problem in reference to mineral extraction (R3.2 on p. 35), the extension of houses (P3.2 on p. 50), hazardous and potentially polluting developments (P4.1 on p. 50 and P4.5 on p. 50) and wind turbines (C2.4 on p. 83). It briefly mentions the need for noise impact assessment in connection with Policy P4 (Hazardous and Potentially Polluting Developments and Contaminated Land).

Because the spatial strategy of the ALDP has been based on strategic growth areas along corridors bordering major roads (as demonstrated by the plan on p. 21), a considerable number of residents in Aberdeenshire already have to live with excessive noise levels caused by major roads. Further housing developments will add to the noise levels that residents have to endure.

The ALDP states that "High quality development within an attractive and safe environment will promote a high quality of life for residents" (5.8 on p.18). To achieve such quality, Aberdeenshire Council must reassess road and other environmental noise quality when new homes are built and when an existing road is altered and/or the amount of traffic on a road increases.

If more people are to be encouraged to work from home (p. 50), the monitoring of noise levels will acquire greater urgency. Specialist housing for the elderly (Policy H3, p. 42) should not be sited alongside major roads because noise creates particular problems for hearing among older people, who cannot screen out background noise. Environmental noise such as road traffic on a major road makes it impossible to open windows.
