PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Objection to the inclusion of **OP4: Site adjacent to Belmuir Lodge, Methlick** as an Allocated Site in the Village of **Methlick** – Page 452 of LDP

Objection to the inclusion of site Adjacent to Belmuir Lodge (OP4) Methlick as an allocated site

The housing proposals contained in the **2021 Local Development Plan** for possible future development in Methlick were also described and analysed in the previous Main Issues Report of January 2019.

In the Main Issues Report the sites FR046 and FR07, which are adjacent to Belmuir Lodge were deemed to be **“NOT suitable for development due to the steeply sloping topography of the sites”** and were **NOT supported!** The report also stated that the site FR06 **“is significantly constrained in terms of topology. It is on a steep slope; access would have to be formed by cutting through the hill which will alter the landscape setting of the site. The site has the potential to impact on protected species. Although potentially resolvable there are waste water and educational constraints. Therefore, the site is not considered suitable for development at this time.”** The site FR07 was similarly criticised, and **“it was concluded that that the site is located on a gradual north-west slope and would be visually prominent in the landscape.”** also, **“there are other sites that can adequately meet the housing need in Methlick and are preferable in Planning terms”**.

To construct a number of homes on such a steeply sloping site will be extremely demanding and make the provision of open space and a soft rural landscape very difficult, and most likely result in a sub-urban appearance. These difficulties were also described in the Main Issues Report, and have been evident when developing the site OP2 on the opposite side of the B9170.

This site is fundamental to Methlick's riverside character. As can be seen when entering the village on the B9107, and walking along the Main Street. The views from the George the Fifth Pleasure Park, the old Church, the cricket pitch and the riverside walk are unforgettable, and should be protected. The building of **any** number of houses on this south-westerly sloping field would destroy Methlick's rural character. (4no. photographs are attached to e:mail to illustrate the impact and proximity that the OP4 site has on the heart of Methlick)

When outlining the Vision for Methlick, in the Local Development Plan 2021, the **first** statement is that **“The setting of Methlick within the valley of the River Ythan is KEY to the settlement's sense of place”**. **The land adjoining the centre of the village is very important in enhancing this sense of place. The importance of the Belmuir Lodge site, OP4, a country pasture that is seen from the historic heart of the village, cannot be overstated. To build here would result in a serious loss, not only to the people of Methlick, but to all the people who pass through, or stay, and visit this attractive and unspoilt place.**

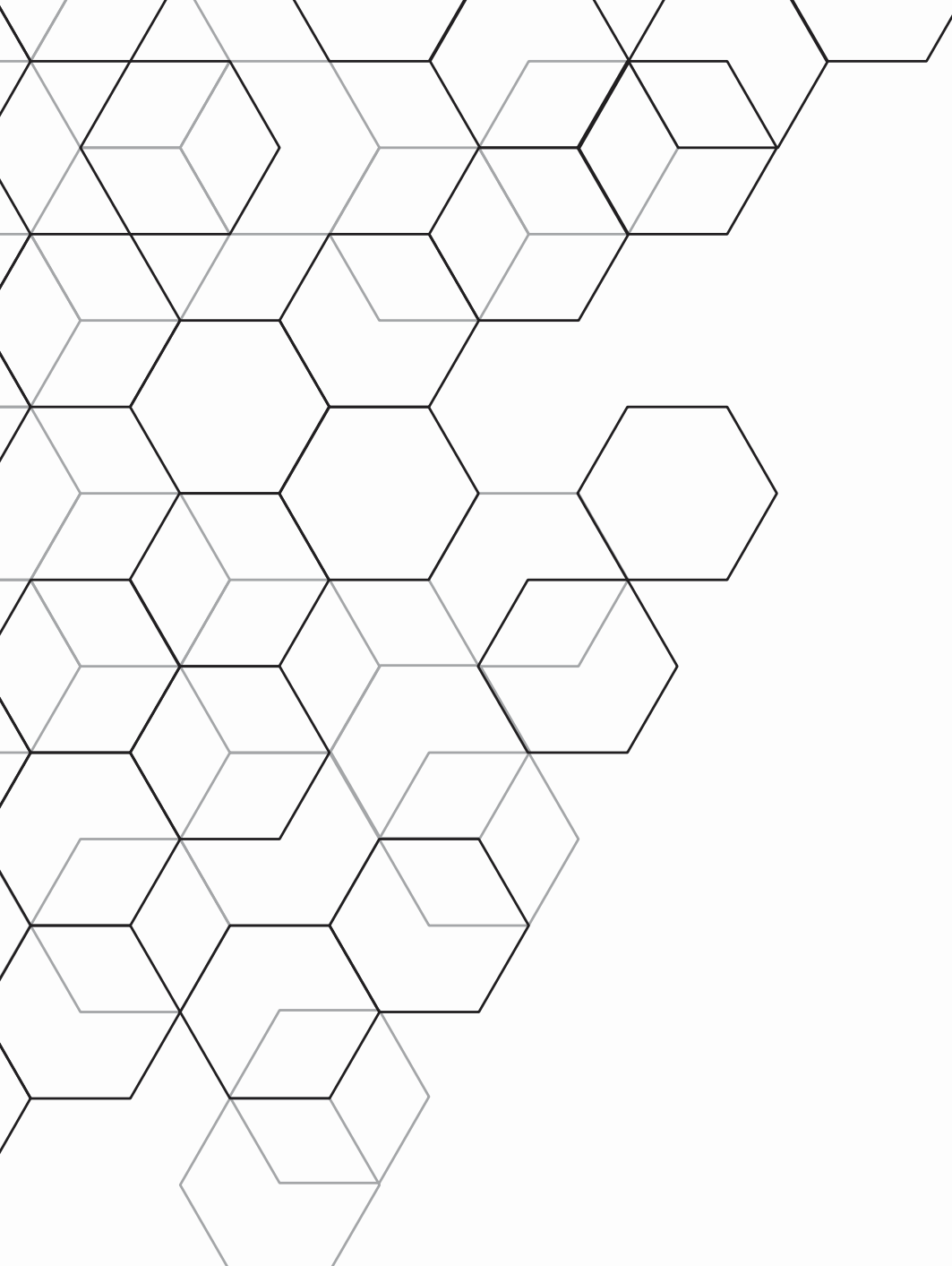
