

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



BB022 Land West of Greenbank Gardens, Fraserburgh

Reason for change:

I write in support of bid BB022, west of Greenbank Gardens, Fraserburgh. The site is accessible to pedestrians and vehicular traffic through from the recently-built development via land controlled by the landowners/applicant as indicated on our bid plan and response to the MIR.

Landscape buffers could be provided along the perimeter of this new site, and also backing on to the existing houses to maintain amenity and provide further usable public open space for dog walking, running/cycling route, etc).

Key extracts that we have taken from the settlement statement are as follows: *“The southern part of the site has been undergoing development with a construction programme to deliver 350 homes by 2031. It is anticipated that development of the remainder of site OP2 may continue through development of parts of the site. However, the Masterplan was prepared by only one of the three known landowners of these sites and a revised Masterplan may be required in order to deliver the remainder of the site.”*

The first part of the Masterplan has now been delivered by [REDACTED], coming to the end of their development. The remaining areas of the Masterplan are constrained – we know this through discussions from various landowners of other parts of the masterplanned area, who have confirmed that they cannot or have no interest in selling land within the Masterplan to be developed. Part of the land included in BB022 has an allocation for open space as part of the current Masterplan that won't be developed into open space either. We are working with a developer on updating the Masterplan to reflect that the remaining land is constrained, and BB022 has been made available by the landowner and a developer has clear intentions to develop the land.

We therefore urge that BB022 be included in the LDP, to run in tandem with plans to progress this development site.
