PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



- Retention of number of houses at 50
- Removal of Coutens Drive as a secondary access to OP2

Reason for change:

Retention of number of houses at 50

Increasing the density of houses to 85 would deprive all residents in Coutens Park of any feeling of living in a rural location by changing the outlook to that of densely populated town setting. Traffic noise would also increase significantly. Whilst it is planned to increase local infrastructure it is unlikely that this will be commensurate with the increase in housing stock.

Removal of Coutens Drive as a secondary access to OP2

Coutens Drive should not be used as a secondary access. As a residential area with a lot of families, increasing traffic down Ardconnon Avenue and Coutens Park would increase the risk of harm to children and animals. During the winter both Ardconnon Avenue and Coutens Park becomes treacherous due to ice and snow with the gradients preventing vehicles from moving up and down. The roadway often becomes blocked and vehicles have been known to slip/skid uncontrollably even at very slow speeds. Any increase in traffic would potentially add to this significant problem which in the five years I have lived here has yet to be resolved.
