

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



**BB021 Land South of Muir Road, Memsie**

## **Reason for change:**

I write in support of bid BB021, land south of Muir Road, Memsie. This site is a logical extension to the settlement, being fairly central within it, close to the crossroads for the bus routes, and would prevent any linear/ribbon development.

The retention of the currently allocated land to the south-west of the crossroad is a 'waste of time' as it has been viewed by numerous developers and is found to be constrained by ownership. The proposed bid site BB021 is near the Cairns but planning applications have already been approved for houses adjoining the Cairn land, within the bid site.

We would propose that a substantial area of open space be allocated to the east nearest to the Cairn and approved sites to best preserve views and amenity to and from the Cairn, and also to provide space for parking for visitors.

In terms of setting, having houses fronting onto Muir Road would mimic the existing pattern of development of the area, either with larger front gardens to maintain the greenery on the existing street or a strip of public open space, which would also be welcomed to enhance the visual appearance, and would link well to the eastern open space and a walking route with greenery through can be created.

There is significant land within the owner's control to the south of the suggested development site that could be used for extensive SUDS/attenuation measures to provide a greatly reduced run-off rate to the southern burn, which has a good flow, and could be maintained by the public open space factoring company to ensure it remains clean with good flows in future, to ensure the drainage in this area would be a significant improvement upon the existing situation, to SEPA's requirements.

The developer interested in developing this site has indicated that a Masterplan could be created to plan out development in stages and to maintain residents' amenity and key views to the Cairn, and also construction SUDS drainage.
