

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Pages 460 to 469 – settlement statement for Oldmeldrum.  
Remove OP6 as employment land.  
Introduce FR110 as employment land in place of OP6.

**Reason for change:**

The OP6 area is public open space associated with the adjacent 400 house development and was included in the overall plan for that development.  
It is laid out and maintained with mown grass and has some perimeter paths, gates and fencing.

There was no bid for employment land here.

OP6 as employment land, being located among houses, OP2, and reserved educational land, R1, would be detached from the other employment land, BUS.

In Oldmeldrum without OP6 there only remains one modestly sized area of as yet undeveloped zoned employment land and that is in the BUS area.

FR110 borders the BUS area and there is an undeveloped corridor leading to it from Mounie Drive, presumably for future access to FR110 without the need for a new access taken from the B9170.

Including FR110 as replacement employment land for OP6 in the Aberdeenshire LDP 2020 will retain a zoned area of employment land similar to that in the proposed Aberdeenshire LDP 2020.
