

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

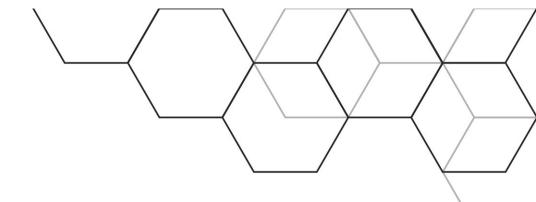
Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. We will publish your name as the author of the comment, but will not make your address public.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I wish to object to the proposed Local Development Plan for the changes in Potterton. The Plan would open us up to mass development, allowing for over 50% increase in housing over five years. I do not wish this to happen to Potterton and therefore I object to OP1 and OP2 and the destruction of the green belt around Potterton

Reason for change:

The area planned for development is green belt land and is therefore not appropriate for this type of development; this is an unjustifiable loss of green belt.

The roads in the area are not suitable to cope with this type of development. The road running between OP1 and 2 is a minor road with blind corners and summits and is already dangerous for the pedestrians (like myself) and cyclists who use it. This and the road onwards to join the AWPR and dual carriageway into town would not be able to cope with the increased volume. Also, there are several existing dwellings positioned right on these roads and the increased traffic volume and noise would cause increased annoyance and danger to the residents there.

The bus service is barely adequate for current needs, as buses are very infrequent out with the rush hour, particularly on Sunday, and is subject to cancellation without notice in bad weather. Moreover, the only bus route goes into Aberdeen, not to Balmedie where amenities such as school, community centre, shop, pharmacy etc are available. I also understand that there is ancient woodland on or bordering the site; I am concerned that the development would affect the protected species in the area.

As I live very close to the development I am also concerned about the increase in noise and traffic during the development, as well as my and my neighbours' safety as they walk/cycle into Potterton to visit the shop, friends etc. both during the development stage and in the longer term.
