## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

PR1.6 in relation to protected status of Harlaw Park. I would wish to see any Protected Status on Harlaw Park, home of Inverurie Loco Works FC removed from the LDP(P19)

#### Reason for change:

- Decision based on the 2010 open space audit. This does not take into account the additional 130 acres made available at Uryside Park
- Inverurie is well provided with open space sports areas...65% compared with the Shire average of 13%, therefore no requirement for Harlaw Park included as protected area.
- It has been suggested that this proposed protected zone ensured consistency of policy across Aberdeenshire. However this is not the case, as Banff (Deveronvale FC) and Pitmedden (Formartine FC) does not have protected status within the 2020 plan.
- Currently Harlaw Park has a value of £2.4m which allows the club to borrow against to ensure continued expansion and the ability to achieve their ambitions of progress up through the Scottish Leagues. Any protected status would reduce the value to £nil, placing a massive burden and potential survival of the club at risk. We know from previous economic studies the positive impact this club has on the town of Inverurie during match days and also the huge contribution it makes annually to local organisations and charities.
