PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Our clients support the continued allocation of OP1 - Cromleybank, Ellon for mixed use development (980 homes, a new primary school and associated facilities and 2ha of employment land) for the reasons outlined below.

Reason for change:

The site was allocated as OP1 – Cromleybank, Ellon for mixed use development in the Local Development Plan 2017 and our clients support the continued allocation.

The site is critical to delivering the scale of housing in the Formartine Area which is anticipated by the Strategic Development Plan. The site remains one of the largest single allocations in the Aberdeen to Peterhead Strategic Corridor for the provision of new housing.

The site will be instrumental in contributing affordable housing units towards Scottish Government targets. The site will provide housing combined with shops (with a focus on local convenience shopping), economic development opportunities, and community facilities, and the new Academy & Community campus more recently constructed within the development site will contribute towards a high quality, attractive, sustainable neighbourhood.

The site will also provide the East-West Link road which is supported by our clients and favoured by the wider public. Our clients also support the Council's boundary amendments in order to provide the required road network which will ensure traffic generated by the site is accommodated. Our clients also support the vision to create a strong sense of place and identity at the site by encouraging a gateway feature for access to the site from the B9005.

Our clients welcome the encouragement for sustainable communities, with the key focus being active travel. The site will provide connectivity to the Ellon green-blue network as well as other opportunities to connect with existing links into the path network along the River Ythan.

Key development wide infrastructure and utilities/services are actively being advanced, with Scottish Water having now completed the necessary Ellon Waste Water Treatment Works sewer capacity upgrades necessary to facilitate the development. Scottish Water have also recently completed an extensive Aberdeen to Ellon corridor Strategic Water Impact Assessment (SWIA) and are moving to the next stage of advancing detailed

design and associated implementation programme in conjunction with our clients, in order to provide future connections to this and other allocated developments along the corridor.

Overall, our clients continue to support this allocation and recognise its importance in delivering the required scale of housing in the Strategic Development Plan, as well as providing economic opportunities and community facilities, improving sustainable communities and connectivity to active travel routes in the surrounding area. The continued allocation will allow the site to contribute to transforming Ellon into a high quality, attractive and sustainable location.
