PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

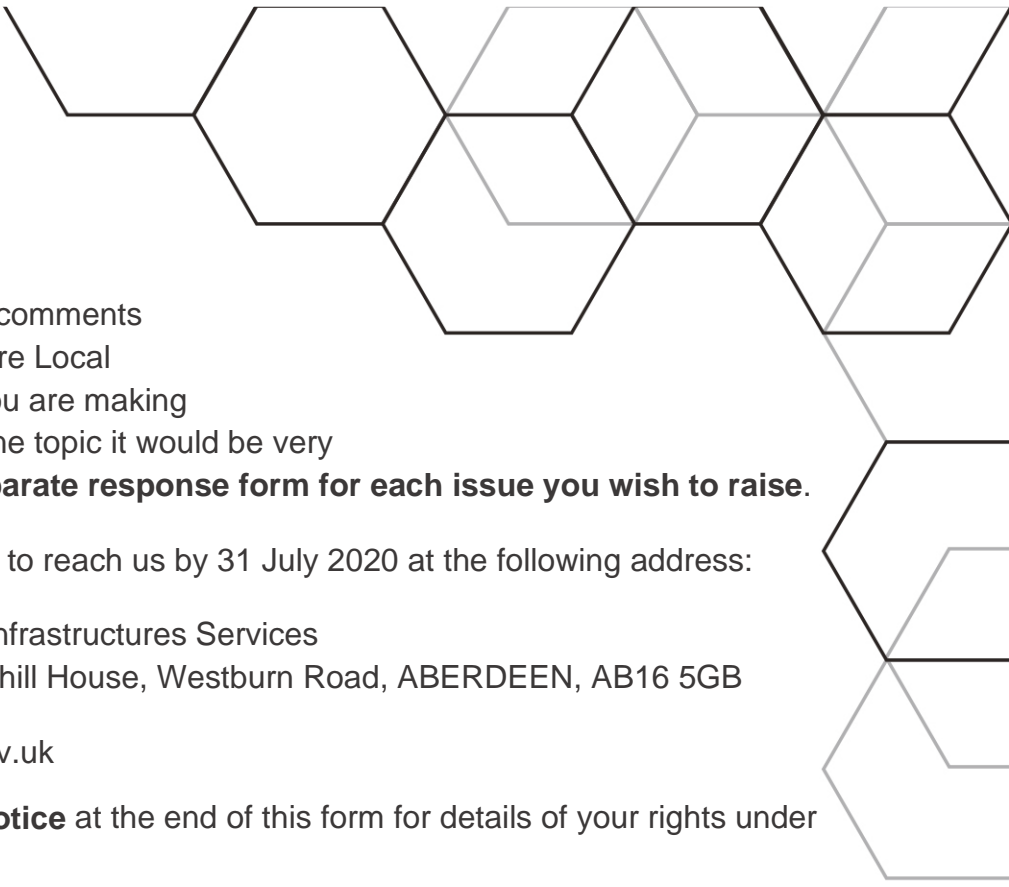

Reason for change:

I am challenging this application not because I object to homes being built where needed but I object to the application being awarded to the same developer who was responsible for the homes on Wealthyton Way. The reasons for my objections are as follows: -

1. After completing 9 houses [REDACTED] leaving a large amount of waste-ground, large piles of soil and assorted materials which continue to be an eye-sore to residents of Wealthyton Way – ten years later.
2. In the following four years the party has managed to build 1 more house on the development which differs in the design to the other houses on the estate quite considerably.
3. If further houses are to be considered what guarantee do residents who live nearby have that they will be completed in a timely manner and that the party has the funds to develop that many homes?
4. Also what guarantee do residents have that the current site will be cleared and that a future, larger site, will not be left in a state of disrepair for a further ten years?

If this development is given the green light then the least residents deserve is for the environment in which they live to be clean, safe and clear of building debris. What concerns me is that all the power is given to developers and that the county council cares nothing of those directly affected by developments.
