### Reason for change:

I object to OP14: Land Northeast of Thainstone Roundabout, Inverurie which is identified as a site suitable for uses as a halting site for gypsy/travellers and /or employment land. The site should revert to its current LDP allocation, i.e. reserved for business use.

The site was previously safeguarded for business use in the LDP 2017, as were all other business use sites within the Crichie / Thainstone employment area. This position should be maintained and any future proposal for delivery of a gypsy / travellers site, if it be proposed on a site within Inverurie or the wider area, should be assessed on its individual merits within the local development plan and all other material considerations.

The proposed allocation states a halting site for gypsy / travellers is required within the Thainstone / Crichie employment area and this site has been identified as the most suitable location within this area for such a use. There appears to be no justification for this site being chosen. The Council should therefore be required to produce their assessment of all locations that were considered through this process and issue it for consultation and appropriate responses from interested parties.
