# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Restrict the P19 protected designation in Inverurie to Colony Park, by excluding the Harlaw Park football ground.

**Reason for change:**

Inverurie Community Council is fully supportive of the principles expressed by the open spaces policy PR1.6 set out by Aberdeenshire Council in the proposed Local Development Plan 2021. We believe such proposals should be applied consistently and fairly across the Shire. ICC is of the view that there has been too much loss of managed and wild open spaces within our community. However, we are also of the view that the slightly retrospective nature of this change with respect to Harlaw Park Football Ground, when previously it had been intimated that the Local Authority was considering developing buildings on and around the site, is obtuse and unfair. Adequate opportunity should be given to the owners of the site, Inverurie Loco Works Football Club, to bring forward proposals for the type of development envisaged by the extant local development plan.
