PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I wish to see stronger measures and protections in the Environment and settlement reports put in to place to prevent coalescence of smaller settlements in the now A92 corridor between Stonehaven and Aberdeen. In particular, I wish to see direct guarantees from the council that measures will be taken to ensure that land already classified as protected or potentially protected should be confirmed as safe from all future housing development with relation to the settlements of Newtonhill, Muchalls and Cammachmore. I am pleased to see that acknowledgement by council officers that these settlements are now vulnerable to overdevelopment, though this sad status is a testament to the failure of the council to protect our communities. Stronger measures must be put in place now to concentrate housing development on planned settlements with suitable infrastructure, access to amenities and to employment. I reiterate my strong belief in the fact that no more houses should be built in Newtonhill, Muchalls or Cammachmore. Indeed, the enormous developments proposed at Portlethen and Stonehaven should similarly be curtailed within the boundaries of common sense and development prioritised at Chapelton.

Remove KN059 (Muchalls) and KN101 (Newtonhill)) as alternative sites for housing development.

KN056 – employment land at Newtonhill should be carefully constructed in order to minimise negative visual impact on the local landscape. Note that Barratt claimed that the OP1 site would not have a strong visual impact, but it is already breaking the skyline from the north, south and coast. Adequate road access should be facilitated and I believe that the slip road should be extended for safety as the volume of traffic will only increase in this part of the A92.

Reason for change:

There is extensive evidence within the settlement statements which demonstrates that unplanned [REDACTED] development such as that which occurred in the example of OP1 Park Place at Newtonhill is only in the best interests of the developer and land owner, not the communities impacted by poor planning. Lack of infrastructure, high dependence on cars and not public transport, lack of local employment opportunities, lack of access to amenities and to green spaces are all now very pressing and serious issues. The village nursery and school is vastly under pressure for space and the only response by Education Services has been to artificially raise the capacity of the school without altering the facilities or fabric of the school buildings. These issues are mirrored in neighbouring settlements and even in the larger communities of Stonehaven and Portlethen. It is vital that the council takes strong action to preserve and enhance green spaces as biodiverse places and spaces for recreation and health. Presently, the language about these issues seems to me to be a little cagey. There are concerns based on what happened with Barratt that the council will choose to similarly choose to sell off other land gifted to the village, such as the playing fields or the coastal park.

The environment and settlement reports highlight the need to protect these communities from environmental factors such as flooding and loss of habitat/green spaces, as well as the risk of coastal erosion. I would like to see the council undertake a tree planting initiative in suitable areas of protected land which would help reduce the impact of climate-change on these communities and better monitoring of building sites and contractors. I can't believe the number of violations reported to SEPA over the last few years alone.

Sites KN059 and KN101 should be removed from the alternative housing development site because the site is clearly indicated to be contrary to planning priorities, is unsuitable in terms of flooding and other key planning reforms, it violates green belt and would place undue pressure on local amenities without adding needed local employment, etc. The former violates the conservation area and the latter is a vast housing proposal that would lead directly to excessive overdevelopment. If what happened with OP1 were to happen with this site, it would be zoned for 120 and then the council would green light almost double the number of houses on it. Development of either site would be entirely unacceptable.
