PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

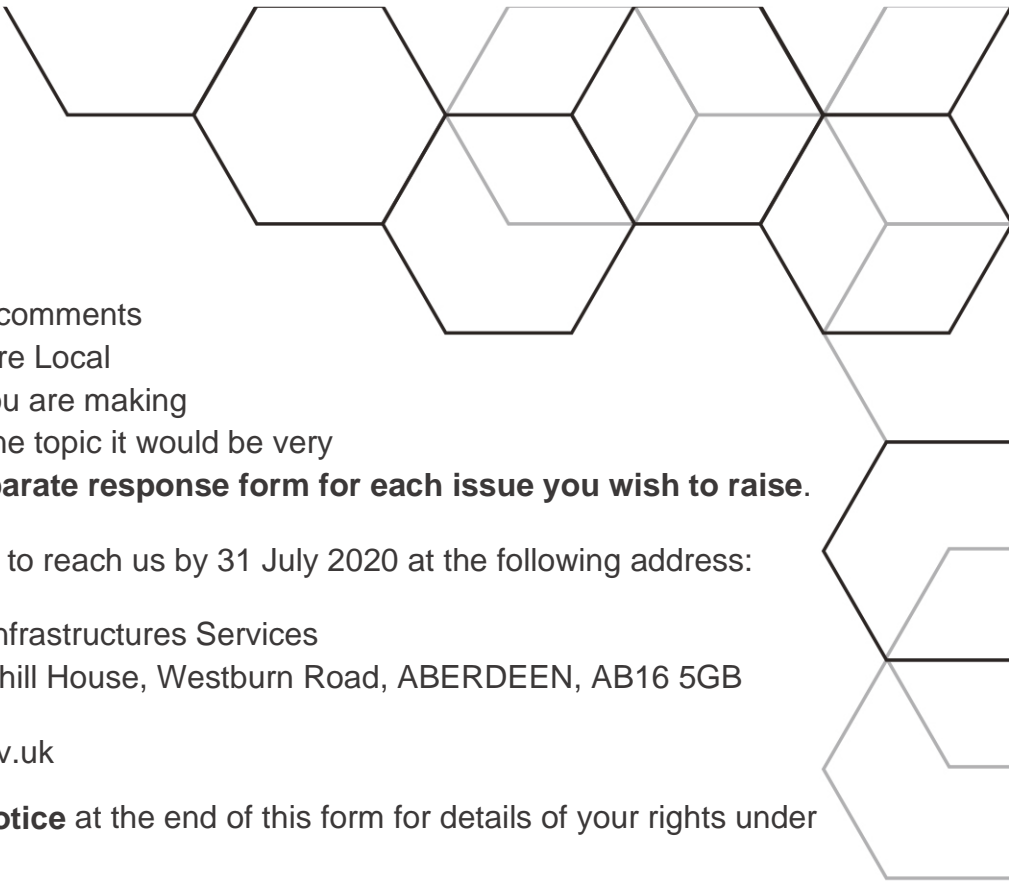

Main Issues Report and Draft Proposed Local Development Plan 2019: Appendix 4 – Garioch part 2 Midmar Development Bid Site Reference GR074 (Land West of Midmar Public Hall, Roadside of Corsindae, Midmar).

Reason for change:

████████████████████ dwellinghouse adjoins the proposed development site GR074 objects to the loss of the protected land (P4) and the increase in the housing allocation on this site.

It is proposed to increase the capacity of this site from 10 to 20 homes. Only two of the original 10 homes planned for this site have been built and these remain unsold since 2015. The additional 10 homes proposed are to be built within an area of protected land (P4) for development of a public garden adjacent to the village hall. This area of protected land has been fenced off with Heras Fencing within the building site making it inaccessible to the community. Although the local community still have an aspiration to create a public garden the landowner has not actively engaged with them to achieve this.

The Aberdeenshire Local Development Plan 2017 Settlement Statements Garioch Appendix 8d stated that Midmar Protected Land (P4) should be respected for landscaping with the adjoining site and the development of public gardens adjacent to the village hall.

There is another site GR054 beside Midmar School which would be better suited to meet the housing needs of the village and sustaining the role at the local primary school. The planning officers have not preferred this site due to the presence of ancient woodland. The landowner of GR054 disputes the land being described as ancient woodland as there is evidence of cultivation and a network of small stone dykes.

As a resident of Midmar village I would support the inclusion of GR054 in the Aberdeenshire Local Development Plan 2021 instead of the planning officer's preference for GR074.
