# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

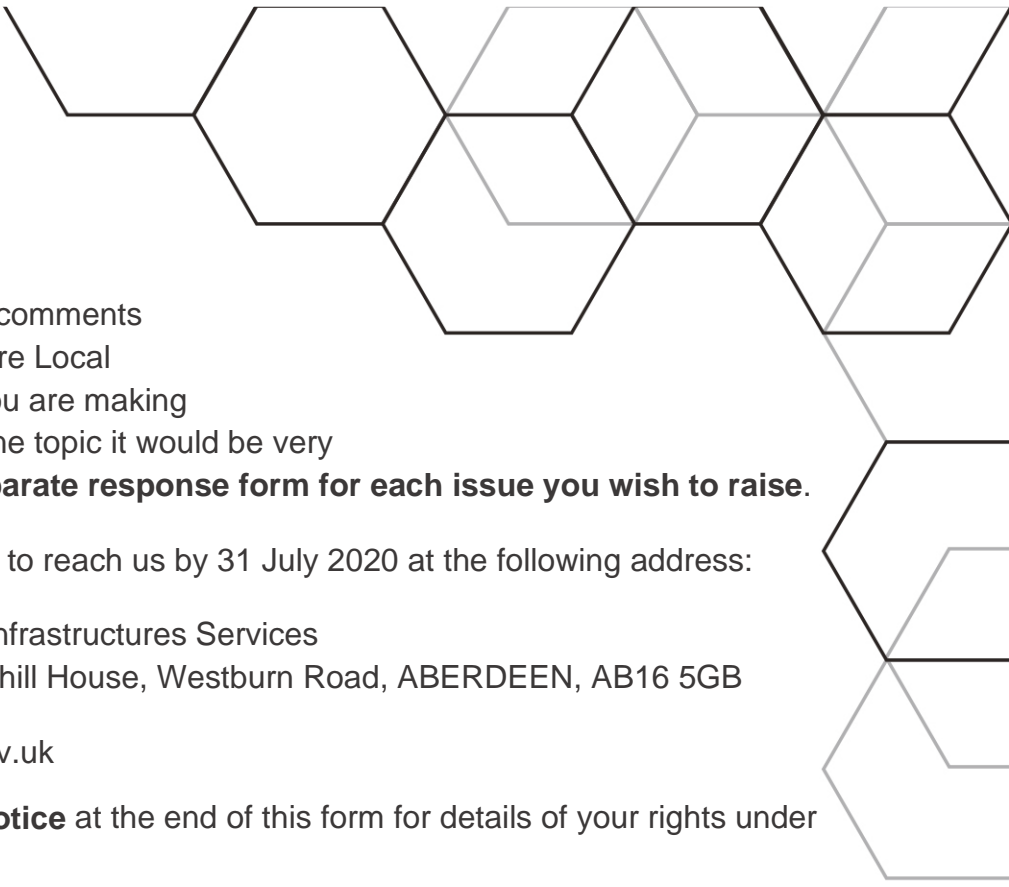

# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I am strongly supportive of the plan to identify land for allotments in the village of Blackburn. The benefits of creating such a resource are enormous and obvious, as indicated in the Scottish Government's local food growing strategy. To list a few: reconnecting people (and especially children) with their food, physical activity, social interaction, greenspace health, community cohesion, reduced greenhouse gas emissions associated with local, esp. organic growing, and food security.

I am a regular dog walker around the perimeter of the proposed site adjacent to Avero Park and can vouch for it being little used for exercising dogs or for any other recreational purpose at present. Adjacent fields are in frequent use for dog walking. I do have some concerns that the site is rather exposed, being on a hillside with little shelter, which may restrict the range of fruit and veg that can be grown there, but if this is the only site available then I would support its use. Are there any alternative sites? There is already a significant shelter belt separating this site from the adjacent housing and I am sure that with support from the Council the site could be developed sympathetically (e.g. more screening and careful provision of car parking to minimise the impact on local residents. Hopefully, some of these residents will see the advantage of having a well-run allotment area close to their homes – what better than to be able to pop out to the veg. patch in the evening after work and bring home home-grown produce for dinner!

I feel confident that as the population of Blackburn matures, given the composition and age of the current housing stock, and as knowledge of the resource spreads, there will be considerable demand for such cultivatable land within walking distance of most of the houses in the village. It would be a major error to overturn the decision to put the Blackburn allotments in the LDP at this point, given the shortage of such resources across the Shire and the increasing interest in the wider population in growing their own produce.
