PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

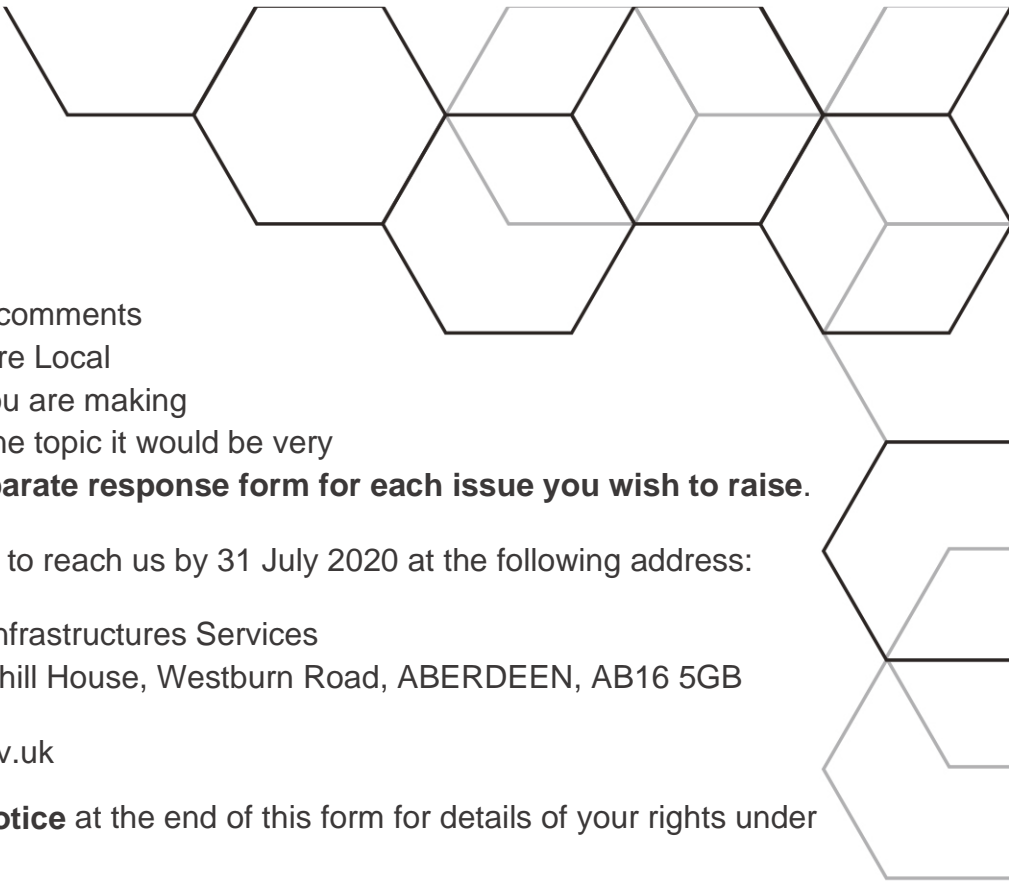

Reason for change:

I would strongly object to the 11 house proposed development in Findon village.

Roads in the village currently do not meet road standards. Some are just not wide enough, most have no pavements, and visibility is poor on most of them, especially some with blind corners. There is no 20 mph or speed bumps to stop cars speeding through the village. There is no public transport in Findon therefore it could mean a further 22 cars (assuming 2 car family) coming in and out of the village. Additional traffic increases would be a major safety concern to the adults and children in the village.

This year we have had many water supply problems and power cuts. Increased houses would be a drain on these.

How can we remain a coastal village when more houses are built, we will all end up merging together, there is no justification for them especially when there is a major housing development across the dual carriageway and nearby at Marywell, all of which have houses up for sale.

The village has no public transport, shops, parks or other amenities or space to add these things. Any plan offset to build anything would not benefit the village as no space. Yet they would manage to squeeze in 11 houses. The village has always voted against street lighting, having this development would mean they are then installed. It would be a shame to change Findon from a small coastal village to yet another housing estate.
