# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

I would like the Council to reject the plan for 11 dwelling houses in the site designated as OP1, Findon

## Reason for change:

The proposed site is a greenfield site which is bound on 3 sides by 2 narrow, winding, downhill roads (on the south and north boundaries) and by what is currently a farm track on the east boundary. The west side of the field is bordered by houses. There is therefore insufficient vehicular access to support the increase in traffic and vehicles resulting from the addition of 11 houses. The proposed development would therefore require significant redesigning of the present road system which will destroy the feel of this village which is currently served by narrow country roads.

The postcode of AB12 3RT currently comprises 20 addresses, some of which do not border the site, but the proposal increases the housing density in that postcode by more than 50% which seems excessive.

Findon is a quiet coastal village which has a diverse range of housing styles and an eclectic mix of buildings giving an "old-world", traditional feel. The proposal to develop what is essentially a mini housing estate of homogenous buildings within a small area in a field which is overlooked by houses on 3 sides is not in keeping with the existing architecture and ambience in the village.

Assuming 4 individuals per house and 2 cars per house – this represents an additional 44 people and 22 cars - plus the ensuing visitors, deliveries, etc. There are no shops in Findon, no schools, no community amenities, no restaurants or leisure facilities. There is no street-lighting, no mains gas, no bus routes - the village infrastructure is simply insufficient to cope with this increase in population and activity. Providing these amenities would have a devastating effect on the village and damage it beyond recognition.

Finally, Findon is a small settled community and many of the residents are retired - many have chosen to live here due to the tranquil environment and community spirit – the changes required to accommodate the development would change this irrevocably. I would therefore respectfully ask the Council to maintain the status of this greenfield site and reject this proposal.
