PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. We will publish your name as the author of the comment, but will not make your address public.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Section 7 Paragraph R2.16

1. Substitute "addition of individual houses to" for "the extension of".
2. Substitute "Houses in clusters" for "Clusters".

Section 7 Paragraph R2.17

3. Substitute "2" for "3".
4. Delete "to" between "not" and "exceed".
5. Insert "(which may comprise two or three clusters in close proximity rather than a single larger cluster)" after "groups" in the third sentence.
6. Insert ", unless special justification can be provided," between "cases" and "provide".
7. Insert at end of last sentence "and the amenity of the existing houses therein".

Reason for change:

1. Actual extension of the group/cluster should not be encouraged: rather infill should very much be the justification on almost every occasion and not simply 'in most cases'.
2. The existing wording refers to relationships between groups rather than what is required to constitute a cluster or group.
3. A potential 60% increase to the size of a small group of houses is not justifiable.
4. Grammatical.
5. The policy should prohibit artificial separation of clusters which may not all relate well to each other but which nonetheless make up a large group to which further additions should not be made. I am thinking particularly of the situation where it was arbitrarily determined that my own house and my immediate neighbours were closely related to houses at the far side of two fields but not to a closer group of houses, simply to allow additions to be made to it.
6. As 1.
7. Development should respect the fact that the group is in a supposedly remote country area.
