PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

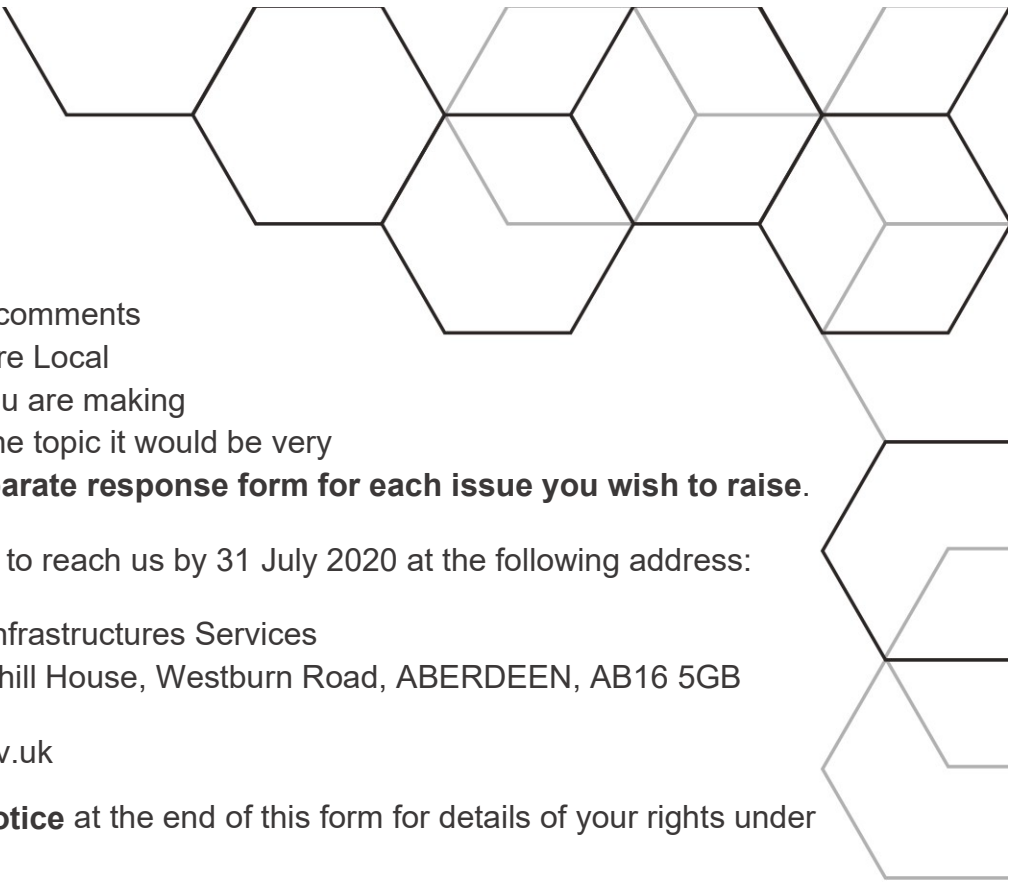

Ref LDP2021NN – Appendix 7C Settlement Statement Formartine/Potterton pages 476-479. I object to the proposed plan to develop sites OP1 with 172 homes and OP2 with 61 homes.

Reason for change:

I built a house in Potterton 21 years ago as it was a lovely quiet village, where we brought up our young son.

There is a football pitch, swing park and shop and very little traffic.

I know when the AWPR was being built a lot of heavy trucks thundered passed my door as the whole house shook.

This was not ideal as they passed the main children's play area and I think they were very lucky there were no accidents.

I wouldn't want to go through this again for the next few years with the new housing.

When I built my house I was told by the council that I had to clean out a burn on the other side of the road for 300M as Potterton was bad for flooding and my house would only add to the problem, so I have no idea how much a problem all the new houses will cause.

I also think the traffic at the junction on to the B999 from Panmure Gardens would be backed up considerably.

There is already problems at this junction when cars are parked on the road to access the shop, sometimes blocking the right turn off the B999.

The proposed area highlighted for development is Greenbelt designated and there is no justification for removing the Greenbelt status. Other sites are available in the area which are not designated Greenbelt, such as the site at Blackdog.

This was all over the local newspapers promoting new employment because of the new business units and a new cinema, but this seems to have been shelved.

The development of OP1, 2 and the additional reserved status sites would double the size of the village. The scale of this increase will take away a village and make it a small town.
