

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

The following two suggested changes relate to our ongoing discussions with interested parties regarding use of the port for handling large volumes of both carbon dioxide (import) and hydrogen (import and export) by ship.

Recommended Change 1

Policy PR2 Reserving and Protecting Important Development Sites

PR2.2 – Amend text to:

National Developments that directly affect the area covered by this plan include proposals for the contribution to capturing and storing carbon, ***the production of hydrogen from natural gas as a low carbon fuel*** and making heat generation. Carbon capture ***and hydrogen production*** is specifically promoted at the St Fergus Gas Terminal but also at other locations ***and pipeline corridors*** associated with ***the movement of CO₂ by ship via Peterhead Port and*** pipelines from central belt to St Fergus.

Recommended Change 2

Appendix-7b-settlement-statements---Buchan

Peterhead – P348-364

R2 (Peterhead Keymap (page 356), map 5 (page 361), map 6 (page 362) Amend boundary of R2 area to:

Cover the full extent of the previous (decommissioned) pipeline corridor between Peterhead Power Station and the Tanker Jetty in Peterhead Port. This will allow a connection between the port to the power station where it is expected that there will be Carbon Capture and Storage related developments.

An illustration of this pipeline corridor is provided in *Figure 1* below and is a basis around which to extend the boundary of the R2 designated area north and east to the boundary of the P9 area designated to be protected for '*port related activities*'.

Reason for change(s):

Recommended Change 1:

Peterhead Port Authority has been involved in several potential projects that will require the handling of shipments of carbon dioxide and hydrogen over an extended timeframe. The ability to import and export carbon dioxide and produced hydrogen from natural gas at St Fergus are major components of this strategy. The Acorn project represents a huge potential for Aberdeenshire to be at the forefront of plans to *'take on the challenges of sustainable development and climate change'* and *'to increase and diversify the economy'* whilst securing a low carbon future in Scotland and achieving the targets set out in the Climate Change (Emissions Reduction Targets) (Scotland) Act 2019.

This project also offers the opportunity to maximise the economic benefits of a low carbon future to Aberdeenshire.

Recommended Change 2:

As noted above, the ability to import and export carbon dioxide and hydrogen is an important part of our future strategy for Peterhead Port and has the potential to be a significant contribution to future trade as the UKCS continues its pathway towards energy transition. This recommended change will ensure that all of the land requirement for this important element of these plans is protected under the relevant and appropriate policy within the Aberdeenshire LDP.
