

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

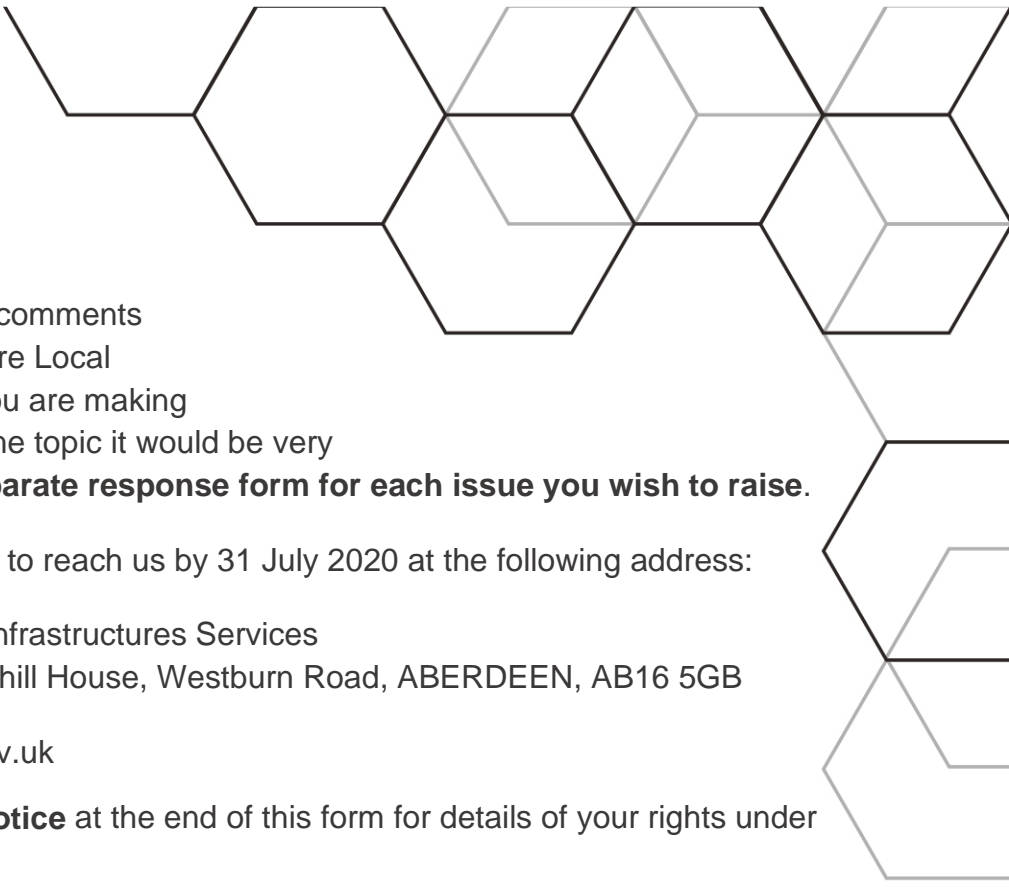

# YOUR COMMENTS

Reference OP3: Ury House, Blue Lodge

Modification that I would like to see is to retain allocation at 51 homes (per Full Planning Permission) rather than increase the allocation to 99 homes.

## Reason for change:

Development at Ury Estate was approved as an exception to regulations against building homes in the countryside (planning consent in 2011) because it was an "enabling development" to restore Ury House. At initial approval, the number of homes allotted for this exception was 230. That total number has increased to over 400 homes to-date, and ten years later little progress has been made towards achieving the (non housing) outcome that was proposed. As a result, Ury Estate is becoming a burdensome housing estate rather than an amenity for the community.

Increasing the scale and density of the subject site from 51 to 99 homes will exacerbate existing challenges (e.g. for homes already allotted to Ury Estate) associated with the following:

- 1) Proximity to historic assets in area
- 2) Buffer strips adjacent to Cowie Water and another small watercourse
- 3) Appropriate road access to the site
- 4) Need for footpath linkages to town
- 5) Preserving the character of Stonehaven/Mearns community
- 6) Pressure on Stonehaven area schools and other infrastructure

Accordingly, no additional homes should be allocated to OP3.

Furthermore, this increase in housing density appears to be at odds with the developers "masterplan" for a five-star hotel and golf course at the centre of the estate. Any change to the OP3 allotment should be done in concert with an enforceable masterplan for the entire estate

Finally, there is more than sufficient potential to provide additional homes in the Portlethen to Stonehaven corridor without adding any homes to the Ury Estate allotments. For example, Chapelton of Elsick alone (which was designed to avoid haphazard development adjoining existing communities) has room for thousands of new homes. Again, no reason to increase allotment for OP3.

In summary, no additional homes should be allotted to OP3 in the 2021 Local Development Plan.
