

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

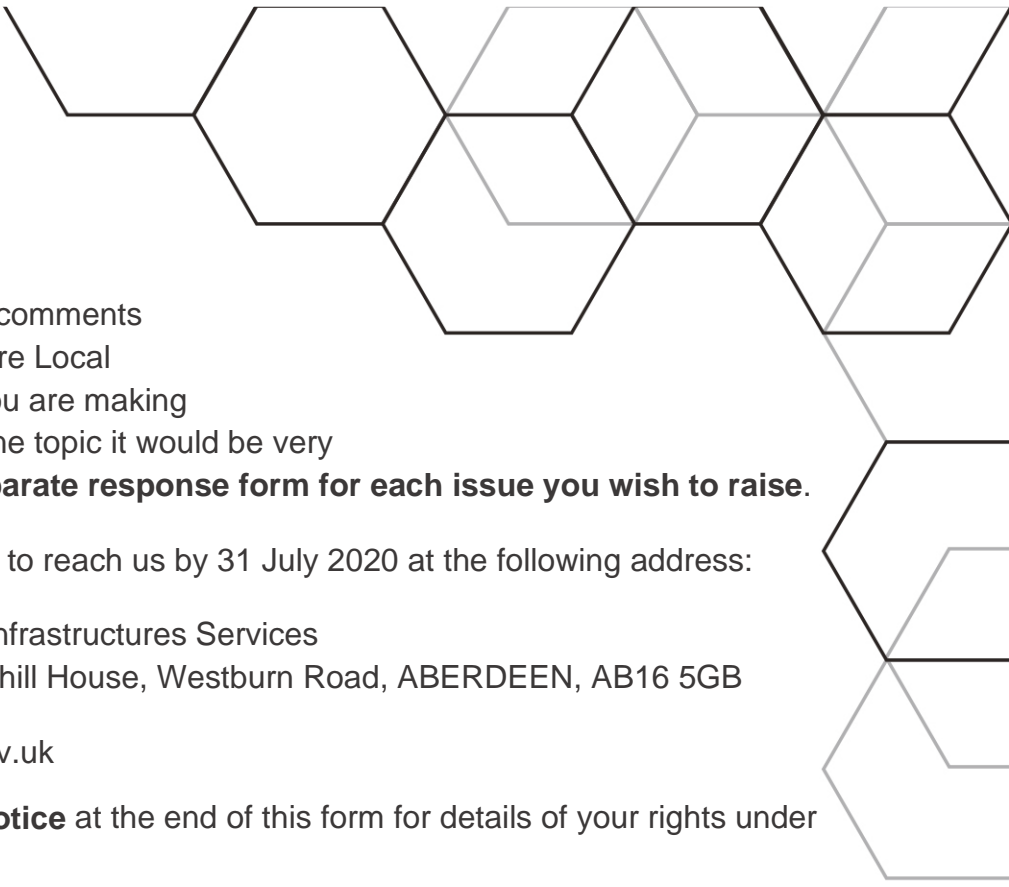

Reference: Appendix 7c – Settlement Statements Formartine – Potterton - page 476.  
The housing development sites OP1 and OP2 on green belt land at Potterton, should be removed from the Proposed Aberdeenshire Local Development Plan.

## Reason for change:

Sites OP1 and OP2 are situated on Aberdeen green belt land, which is intended to protect settlements from inappropriate development. Green belt land is irreplaceable, and also contributes to mitigating climate change.

Loss of such a large area of green belt land would destroy the character of this small rural settlement, which is currently surrounded by countryside.

The proposed development would seriously affect residents' quality of life - local people value their green space more than ever now, for their health and recreation, and do not want to lose it.

Existing schools, roads and other local infrastructure are insufficient for this significant increase in housing.

The AWPR should not be used as a licence for inappropriate development in rural areas. Potterton is not situated within the Aberdeen to Peterhead Strategic Growth Area.

These paragraphs from the Vision statement for Potterton (p476 of Appendix 7c) support my comments:

"Potterton is a small settlement located within the Aberdeen green belt. It is outwith the Aberdeen to Peterhead Strategic Growth Area."

"The settlement has a limited number of services, although it has a local post office and community hall. The use of protected land designations and the application of the green belt policy will contribute to preserving the amenity of the settlement."
