PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

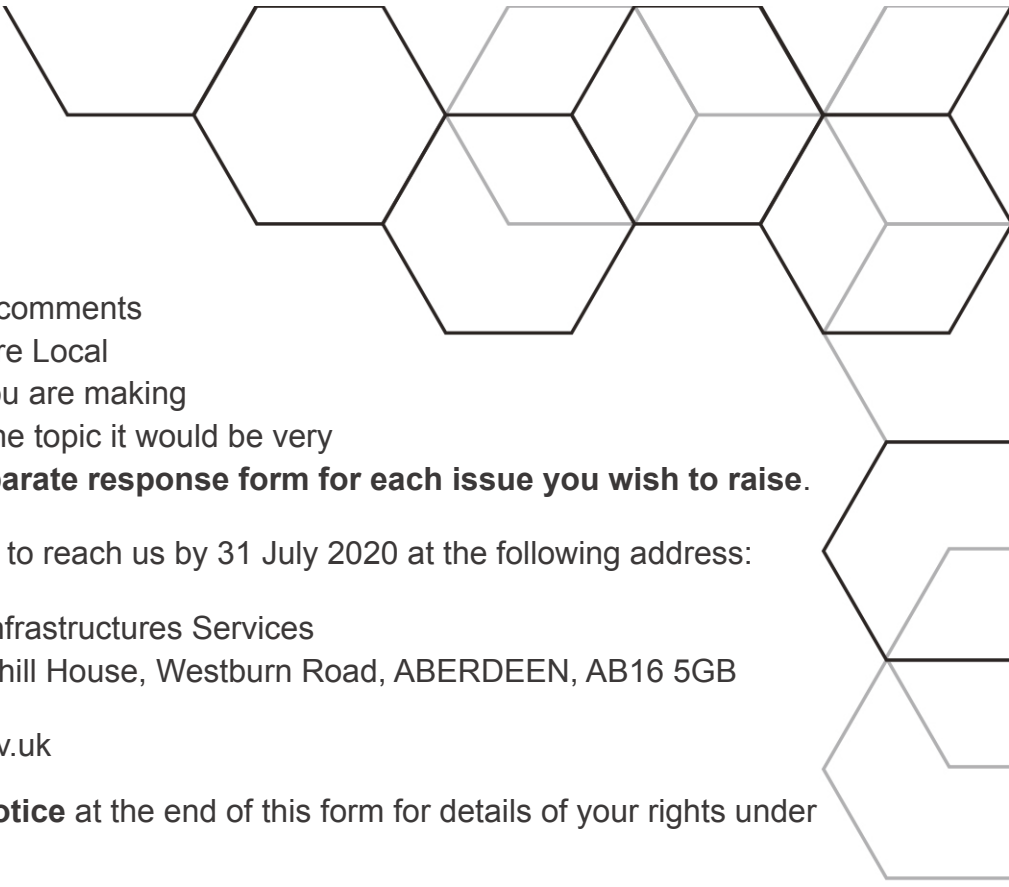

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Refusal of permission to build a road link via Knockhall Road to circumvent the Main Street in Newburgh as part of the P2 development.

Reason for change:

The proposal to build a new road linking part of Knockhall road to the A975 to circumvent Main Street will introduce a rat run through the rear of the village and will potentially increase traffic along roads that do not accommodate pedestrians. It has been suggested by Councillor [REDACTED] that the proposal will ease traffic through the village. What evidence does the councillor have to support this suggestion? The diversion seems to suggest that the main traffic stemming from the proposed P2 development will commute north of Newburgh, based on observation of the new Knockhall development, the majority of traffic will proceed south to Aberdeen. Has the council conducted any traffic monitoring following the development of P1 and the additional traffic that has occurred since a proportion of the new houses are now occupied? If no such monitoring exercise has been conducted on what evidence are the council proposing to build the new road? Have the public in Foveran been informed of the proposal and what is the consultancy process since the proposal of the new road could potentially increase traffic through Foveran village. Finally, due to nature of the proposal, why has the council not held a public meeting when the overall plans were first outlined?

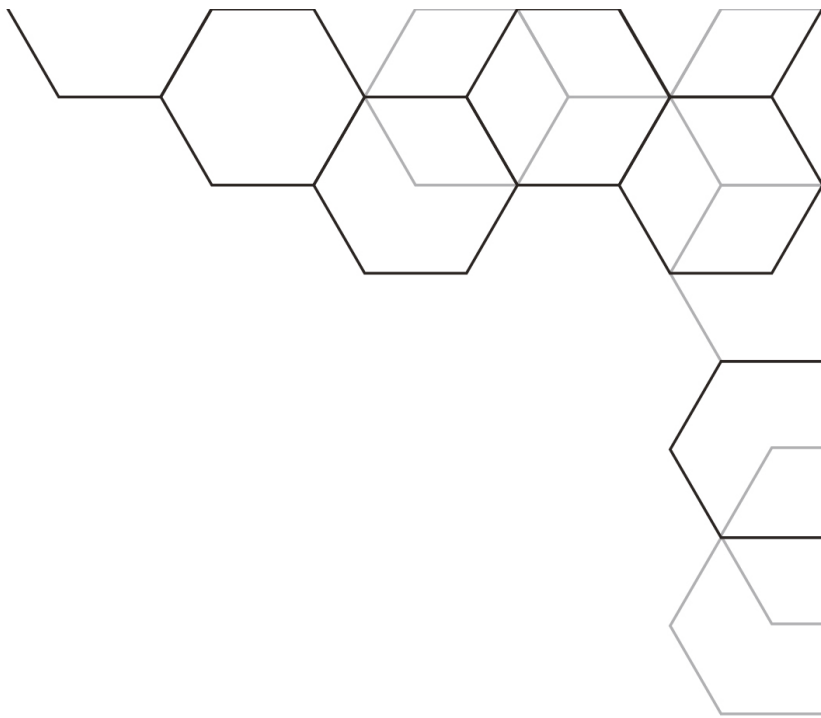
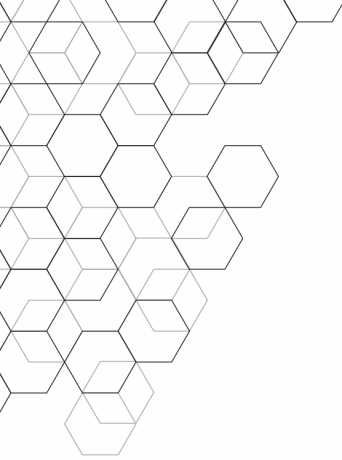
