PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

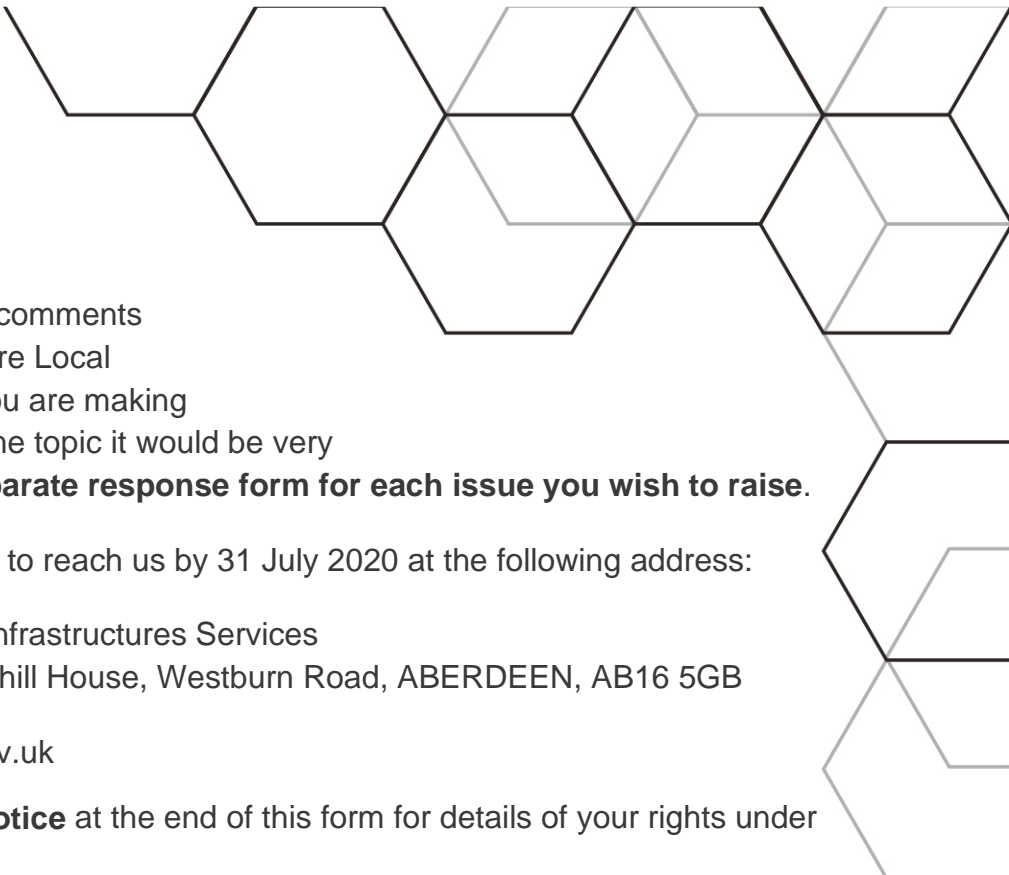

Reason for change:

As landowner/developer of the site I am committed to providing an attractive housing development that will help meet the Local Development Plan's vision for Turriff.

My vision for the development is to provide a mix of house types and sizes to not only meet the local housing need but to create a development that is sympathetic to the landscape character.

I acknowledge that the site will provide Affordable Housing in line with Policy H2 and will discuss the requirements with the Planning Officer to determine the number required and ensure that there will be some units delivered in the early phasing of the development.

As the development is within the 'Major River Valley', I believe the proposed houses should be of mixed materials that are typical of a rural setting to acknowledge the existing character of the area.

The proposed houses will be some of the first buildings that people will see when entering Turriff from the B9024, I feel it is important that the quality of housing is of a standard that the residents of Turriff will be proud to have at the entrance to their town.

Open spaces and areas of soft landscaping will soften the impact of the development and mitigate any negative impact on the nearby Bridgend Farmhouse. Footpaths will also be provided throughout the development linking the new properties with the existing settlement.

I intend to appoint a specialist to carry out the required wildlife and habitat appraisals and will implement any mitigating measures they suggest to increase the biodiversity on the site.

The proposed LDP also indicates that a Flood Risk Assessment may be required which I will discuss with my engineer and liaise with the Flood Team at Aberdeenshire Council where appropriate. The engineer will also be appointed to provide a full drainage proposal including SUDS as required.

As a new access is required on to Bridgend Terrace I will engage in early discussions with the roads department to discuss the most appropriate location for the opening to suit Aberdeenshire Road Standards for speed limits ensuring that the access is safe for all road users.
