## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Representation against inclusion of a "Preferred Distributor Road" north of OP2 and Local Nature Reserve, Banchory in the LDP 2020 (Proposed Plan).

Adopted LDP should reflect the approved masterplan for Lochside of Leys, and the "core roads" transport strategy.

#### Reason for change:

A masterplan for development at Lochside of Leys, Hill of Banchory was approved March 2015. Subsequently, a PPiP was approved in 2017, and the first phase of 56 homes, lying within Site OP2, was consented and commenced in 2019.


This original masterplan included a distributor road between Raemoir Road and the A93. This had reflected the requirements of the local authority, being historically part of a wider proposal to protect a northern bypass route for Banchory. Subsequently, the Council's preference changed, and the requirement for such a route was not included in the adopted LDP 2017.

Through consideration of development across OP2 & OP3 during 2019, it was determined that there was no requirement for, and a lack of public support for, a full distributor road as originally approved. As such, a revision to the masterplan was prepared and approved at the Marr Area Committee on 18 Feb 2020 (ENQ-2019-1750) setting out a new access strategy comprised of connections through each of the development parcels by means of a series of core roads and including new pedestrian and cycle routes. This was considered to make better use of the proposed road network through the sites and to minimise any negative environmental effects of the distributor road.

This was supported by an up to date transport assessment, agreed with Aberdeenshire Council.

Given this context, and that the revised masterplan has been approved by the Council we are surprised and disappointed to note that the Aberdeenshire LDP 2020 (Proposed Plan) still reflects the now superseded distributor road to the north of OP2 and OP3.

As such, the adopted Aberdeenshire LDP 2021 should (1) not reflect the requirement for a distributor road (2) remove reference to the requirement for additional Transport Assessments, as these were approved as part of the masterplan revision (3) should refer to the revised masterplan having been approved in Feb 2020, and that access and connectivity should be via a system of core roads as included within the revised masterplan (indicated on Appendix G of the revised masterplan, below).
