# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Objection to non-allocation of Site MR041 (Wood of Arbeadie), Banchory.

Site should be allocated for 50 homes.

## Reason for change:

A representation was made by Bancon Homes in support of the allocation of MR041 at the MIR stage of the Aberdeenshire LDP (2021), however the site was not preferred for allocation.

We continue to believe that the site is appropriate for allocation for housing. Banchory is a key settlement within the identified Local Growth and Diversification part of the Aberdeen housing market area (AHMA). It continued to sustain a good level of housing completions throughout challenging market conditions in the previous decade and as a location of choice for homeowners, should continue to be supported.

Ongoing construction and strong take up of new housing (both private and affordable) within the Oaklands and Lochside of Leys areas of the town, alongside a range of leisure, retail and commercial development supports the continued expansion of Banchory as a town with more to offer than just as a dormitory town.

There is a continued underdelivery of allocated sites across Aberdeenshire, and as a town which has continued to be a location of choice for residents Banchory offers the prospect of a much better reliance on the delivery of new homes in line with projections.

In terms of housing land allocations, despite the position taken in the Proposed Plan (Appendix 6 Housing Land Allocations) we contend that there remains a housing land shortfall within the Aberdeen Housing Market Area (HMA). A surplus of 80 units is identified in the LDP in response to the SDP Housing Supply Allowance.

However, Homes for Scotland, analyse the housing land supply within the Aberdeen HMA as being short by c.483 units (a difference of 563 units where sites are considered to be constrained or non-effective). Worryingly, there are a number of sites where the bid or previous allocation has been increased by Aberdeenshire Council (in total 287 units) including some sites where this is seemingly without request, where there is no evidence of housebuilder involvement or the site is not evidently in effective ownership.

802 units within Aberdeenshire Council's analysis of housing land supply are from sites of 50 units or below. It is contended therefore that there is significant risk of a housing land shortfall as measured against the SDP Allowance, and this site would be effective in meeting that shortfall.

In addition, whilst not lying within the same area of Aberdeenshire but nonetheless in the Aberdeen Housing Market Area (AHMA), representations have been made previously by Bancon Homes regarding the continued under-delivery of housing at Chapeltown of Elsick. We do not object to the principle of this allocation, but continue to request that Aberdeenshire Council recognise (1) the significant proportion of the effective land supply within the AHMA that Chapeltown constitutes and (2) the number of completions arising from Chapeltown continues to be well below those envisaged in either the 2012 or 2017 LDP's.

In terms of the first point above, Appendix 6 of the Proposed Plan identifies a total housing land supply for the Aberdeen to Laurencekirk SGA of 6,030 homes. Chapeltown is allocated for a total of 4,045 homes, with only 164 delivered as of Jan 2019 (Housing Land Audit 2019). This leaves 3,881 homes remaining, constituting 64% of the total effective housing land supply for this SGA.

In relation to the second point, the delivery of 164 units since commencement in 2015 equates to a build rate of approx. 40 units per annum. Extrapolating this out, even at a more generous 60-80 units per annum, would leave a completion total of only 1,184 units by 2031. This would leave 2,861 units undelivered during the plan period.

This further throws into focus the risks associated with Aberdeenshire Council's assessment of effective land supply, and that without further allocations, the delivery of homes across the AHMA will be well below that required by current and prospective residents.

The site at Wood of Arbeadie is bounded on all sides by woodland, and yet is well related to the existing settlement.

The site meets the criteria of an effective site on the basis of meeting all the tests in PAN2/2010 - ownership, physical, contamination, deficit funding, marketability, infrastructure and land use. With recent Scottish Water investment in Banchory increasing the water supply and drainage capacity, this puts the settlement in a better position than others to bring forward effective sites.

There were various specific points made in the MIR regarding why this site was not prospectively allocated, and these again are challenged as follows:

For both this site and the adjacent MR040 (Tillynarb), waste water and education constraints are noted, however both primary and secondary school roll forecasts indicate ongoing spare capacity. Scottish Water are underway with a growth project, which will be fully complete by the time the LDP is adopted.

Assumptions are also made that development of the site would result in loss or damage to woodland, however we contend that development could be contained within the woodland setting and in particular having regard to the Tree Protection Order (TPO) within this site approved during 2019. Retention of the woodland would satisfy the requirement in the plan for up to 40% open space provision and would ensure any development sat well within its context. Bancon made no objection to this TPO.
