PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

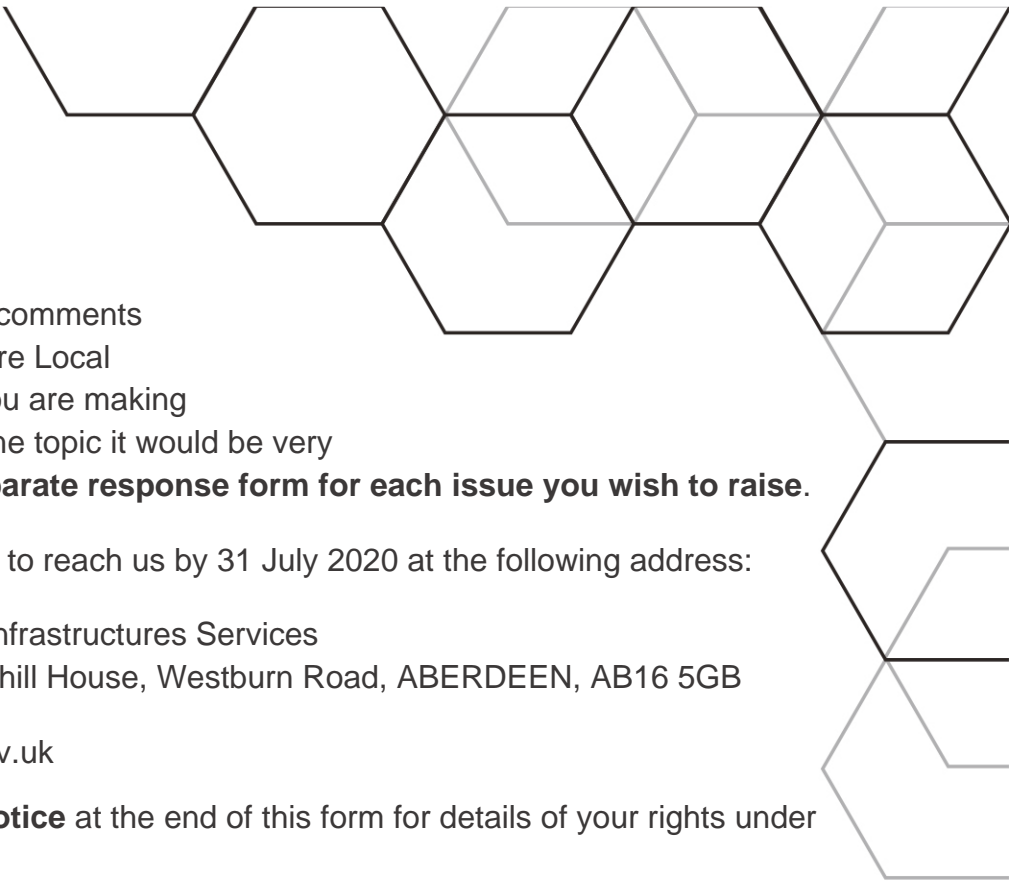

Comments from Belhelvie Community Council Mid-Formartine Ward

Balmedie

OP1: Land at Balmedie South - 80 homes, 11ha employment land, mixed commercial land, retail and hotel

OP2: Land south of Chapelwell - 220 homes

No Comment

OP3: Menie - Erection of 550 Dwelling houses (Up to 500 Residential Units and a Minimum of 50 Leisure/Resort Units), Community Facilities (Class 10 Non-residential Institutions and Class 11 Assembly and Leisure), Development Falling Within Class 1 (Shops), Class 2 (Financial, Professional and Other services), Class 3 (Food and Drink), Landscaping and Supporting Infrastructure.

The Community Council and residents of Balmedie are extremely concerned about the potential heavy volume of Construction traffic passing through the village during the construction phase of the project and the potential large increase in commuter traffic post construction completion. We believe that this will cause Health and Safety issues within the village and put undue pressure on the south exit from the village onto the A90. We strongly believe that this development should incorporate a grade separated junction onto the A90 north of Balmedie village.

Belhelvie

OP1: East End of Park Terrace - 14 homes

OP2: Land at Cairntack (East) - 41 homes

OP3: Land to the East of Cairn View - 49 homes

Whilst the Community Council have no significant objection to these developments as they appear to be a natural extension to the village we are aware that some residents object in principal to extending the village due to a lack of facilities and the poor road infrastructure.

Blackdog

OP1: Land at Blackdog - 600 homes, 4ha employment land and 7ha strategic reserve
No objection raised to this development. The Blackdog Residents Association have indicated that they welcome the development within the village providing that the promised Community facilities materialise.

Potterton

OP1: Land north of Denview Road - 172 homes and community facilities

OP2: Land North West of Denview Road - 61 homes

Belhelvie Community Council have no substantive objections to these developments however are aware that there is a faction within Potterton who object to the village being extended, despite being requested on three occasions to express their actual concerns the Community Council have not had a response other than concern about the volume of houses, the size of the development and the impact on the village.

Generally the Community Council are concerned about the following:

The addition of circa 1800 homes to the parish will put increasing pressure on existing school facilities and as such plans should be put in place to either extend the existing Balmedie School or build an additional school within the catchment area. Similarly the addition of circa 1800 families will put a large burden on medical facilities within the area and the solution to this needs to be given serious consideration by the Council.

There is general concern about the road infrastructure around the parish being able to adequately and safely cope with the increased volume of traffic and upgrades to some of the road infrastructure needs to be given consideration. In addition the potential increase of 1800 families will require a full review of the existing bus services around the parish which at this time are felt to be inadequate.
