PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Section 10 E1 Natural heritage nature conservation

Reason for change:

The LDP states it will not allow new development where it may have an unacceptable adverse effect on nature conservation.

I support that statement wholeheartedly and point out that a proposed development in Aberdeen City threatens the Green Belt in the Shire following a bid by the [REDACTED] [REDACTED] in OP46 for 150 houses in an area previously shown as unacceptable for development.

The proposed development would impact severely on local residents and on the Causeymouth Road.

The development is not needed, the amount of unbuilt development and with consent is likely to be sufficient for all needs in the former Grampian region for many years to come. Covid19 will reduce the requirement even further, through reduction in employment, increase in working from home and centralisation in the centre of Scotland.

This application is inconsistent with the City and Shire's Strategic Plan 2018. The city has not adhered to those policies the Shire has done so and is to be commended.
