# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

# **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

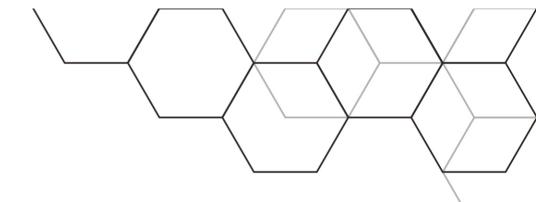
Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Full layout information on the proposed site OP1 Fordyce required Objection to development

#### Reason for change:

The site highlighted is a large field in so much that the proposed houses could be located anywhere in this area. More detailed information is required to where exactly the 5 houses are to be positioned at this field backs directly onto my and neighbour's houses. Information required would be type and aesthetic of houses, physical and exact location.

The objection to the development to Fordyce is:


1/ OP1 is a large field in where, if permission is granted this sets the precedence to further development. If 5 are approved – another 5 will be applied for – then another 5 etc until the entire field is an estate. This will have a detrimental effect on the layout and image of Fordyce as it stands. It will also encourage increased traffic, noise and potential crime in an area where the majority of residents are elderly.

2/ at this field looks directly onto my and neighbour's houses. Further housing will not only obscure countryside views but overlook into 15 properties

3/ This is a CONSERVATION area of historical value to Aberdeenshire, one of 40 in Aberdeenshire but one of few which boasts a lived in medieval castle and medieval kirk. This therefore gives Fordyce unique status in Aberdeenshire. The village is now at its fullest in terms of building space. Current housing follows the original lay lines of the village only. Any further additional building will significantly alter the appearance and value to the current layout. With tourism high on Aberdeenshire council's agenda with the promotion of NE250, Fordyce uniqueness is very much part of this and should not be altered excepting for existing improvements. It would be appropriate of the council to visit the village to recognise its historical value.

4/ The village has a woodland attached and attracts a large amount of wildlife. Adding additional buildings will increase noise and pollution levels as well as traffic levels and may have a detrimental effect to the local wildlife.

- 5/ The proposed road access is opposite to a school where there is currently no infrastructure such as street lighting and therefore poses a danger to locals and school attendees.
- 6/ This proposed road access will have a detrimental value decrease to the owners property at the intented new road access.
- 7/ We moved to the village in 2019 after being assured by our solicitor that no planning requests / permissions were lodged or pending. If we had been made aware of any potential development we would not have moved to Fordyce. We have subsequently spent thousands of pounds upgrading our property. The proposed OP1 will significantly alter our experience of living in the village of Fordyce as well as potentially devaluing our and our neighbour's properties.
