PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

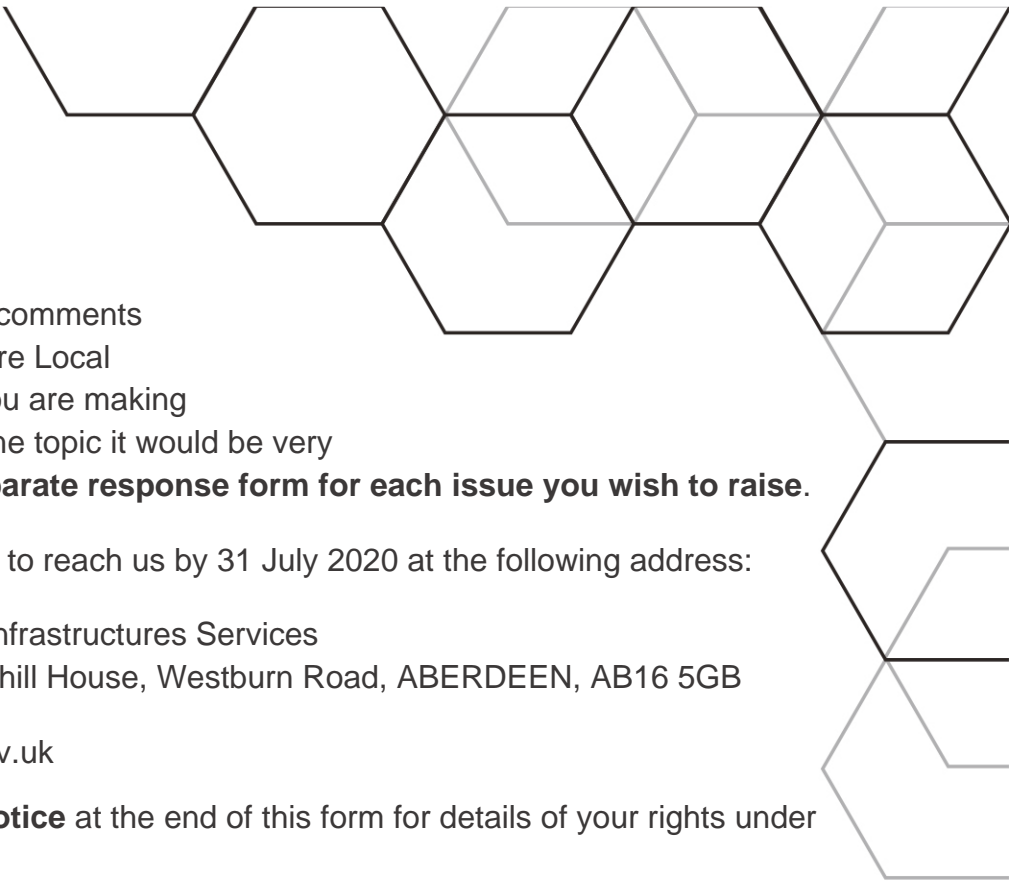

Appendix 7D Garioch settlements, Inverurie and Port Elphinstone

Change of classification for part of the area R2 from protected/reserved to allocated & preferred.

Reason for change:

████████████████████ R2 area within the Inverurie & Port Elphinstone development plan, I have not been consulted by Aberdeenshire Council in relation to the classification of protected/reserved status of my land.

Almost half of R2 is well outside the 200 year flood plain area and I will not make this available for the expansion of riverside park only. I can't see any reason why the part of this land area (out with the flood plain) could not be available for future development to allow the area within the 200 year flood plain to be utilised for the expansion of the riverside park at a later date.

The area ██████████ proposed for housing would give connectivity to the area of housing currently being developed at Portstown (over the lochter).

████████████████████ I object to **all** of the area being classified as protected because it will in future restrict the expansion of the riverside park which is a great environmental benefit to the Inverurie community. I do however propose that mixed use approved status be allocated to R2 to allow for both a small scale development & also the expansion to riverside park.
