I wish to object to the Proposed Local Development Plan for the changes in Potterton. The proposed LDP would open up mass development in the village which I don't want. I object to OP1 and OP2 and the destruction of Greenbelt.

## Reason for change:

Inappropriate use of Greenbelt due to existing more suitable areas that could be used avoiding an unjustifiable loss of Greenbelt land in the area. As a regular visitor to the local ancient woodlands on a daily basis these need to be protected from development. I also have school age children and the provision is already stretched and due to be at 118% capacity in 5 years. Therefore, developments on the proposed scale would flood the system entirely. I feel there has been a total lack of community engagement and Covid-19 being used as the excuse if this is so then all plans should be side-lined until such time public consultation can go ahead. Furthermore, as Potterton is a 'rural' village there is complete lack of infrastructure to support such development with road safety already a major concern without the additional loading this development would cause. This would be 300+ additional vehicles in the village with no upgrading to the track roads surrounding the area.
