LDP 2021 NN I wish to object to the proposed local development plan for the changes in Potterton. The proposed LDP would open up mass development in the village which I don't want. I object to OP1 and OP2 and the destruction of Green Belt.

**Reason for change:**

Inappropriate use of Greenbelt due to existing more suitable areas that could be used avoiding an unjustifiable loss of greenbelt land in the area. As a regular visitor to the local ancient woodlands on a daily basis these need to be protected from development. I also have school age children and the provision in the area is already stretched and due to be at 118% capacity in 5 years. Therefore developments on the proposed scale would flood the system entirely. I feel there has been a total lack of community engagement and COVID19 being used as the excuse if this is so then all plans should be sidelined until such time public consultation can go ahead. Furthermore, as Potterton is a 'rural' village there is complete lack of infrastructure to support such development with road safety already a major concern.

Without the additional loading this development would cause. This would be 300+ additional vehicles in the village with no upgrading to the trunk roads surrounding the area.
