

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Change of classification of R2 status to allocated & preferred.

Reason for change:

████████████████████ the R2 area at Howford, which has been classified as protected I'd like to strongly argue my case to change the classification of R2 to allocated & preferred.

We put a very clear proposal to Aberdeenshire council which included a manageable area of land for development and also incorporated affordable housing, as well as, & in my opinion, a very healthy expansion of the Uryside park.

At no point throughout the consultation process did Aberdeenshire council highlight that the area of land ██████ (R2) would be classified as protected.

The area of land we proposed be designated for housing, is well out with the 200 year flood plain therefore I can't see any reason why the council have designated the entire R2 site as protected.

I firmly believe that our proposal put forward to the council is the best of both worlds, where the planning gain from the housing being used to create better infrastructure i.e. Howford bridge upgrade and also allowing Uryside park expansion improvements including bridge crossings

████████████████████ we are not against the expansion of Uryside park as we believe it to be great addition to Inverurie's green space which will benefit the community. We do however object to the entire area being classified as a park and we feel the area proposed for expansion (within our proposal) is more than sufficient expansion space.

I feel that the only way we could support the expansion of riverside park would be for the classification of R2 land to change to a "mixed use" development which would allow substantial community benefits, infrastructure improvements & a manageable development opportunity.
