PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

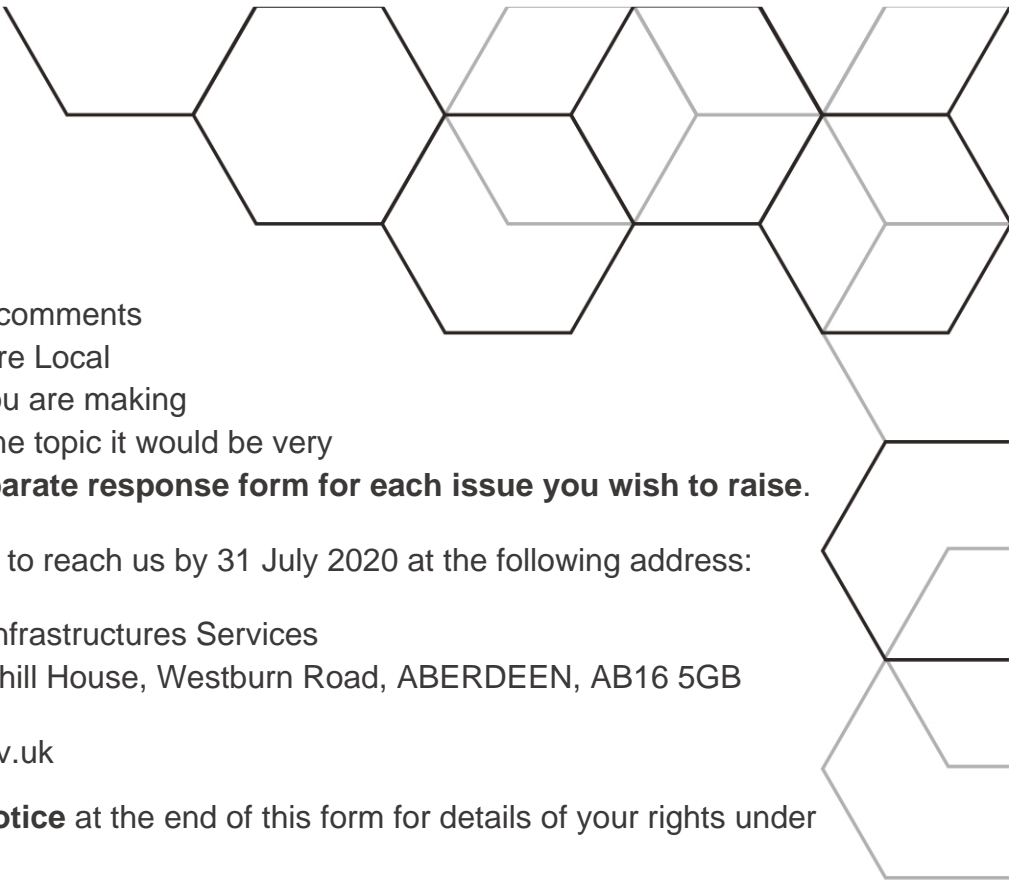

Removal of Proposal OP1 – Land South of Earnsheugh Terrace form Appendix 7e Settlement of Statements- Kincardine & Mearns – Page 667 – Allocation of 11 homes

Reason for change:

Findon is a historic fishing village surrounded by SSSI land and is made up of a mix of fishing cottages, coastguard cottages and crofts. There are a few modern homes in the mix but a whole field of 11 new houses would be totally out of place.

My objections to this proposal, as well as changing the aesthetic look of the village, are mainly the access to this site for development and future living.

The access road cannot surely be wide enough for large vehicles during any building phase as it is only wide enough for one car one way currently in many places? It is a very steep road and has no pavement for pedestrians when there will be increased traffic. The access for anyone with a wheelchair, mobility issues or even a pram will be almost impossible and especially in wintertime when the roads can be treacherous due to the steep incline. There is a nasty bend in the access road that has no visibility for oncoming traffic. Also, I have witnessed many near accidents of vehicles zipping in and out of the current access road and not giving priority to cars on Findon Road. This has previously been reported to Survitec Survival Craft. The incident of this will surely increase and an accident will be inevitable, safety should be paramount in your consideration.

All roads to and from Findon are narrow country roads with poor visibility and poor passing places on grass verges. If there are another 11 houses planned this will significantly increase the vehicles using these roads daily and increase the safety of pedestrians and cyclists who walk on the roads as there are no pavements or cycle lanes.

This development of 11 houses are likely to want the amenities that come with a new house...streetlighting, buses, pavements, cycle lanes and a route to walk to school.

Findon is unique and quaint and we would like it to remain this way and we do not welcome any of these changes. If we did prefer to live with these amenities, we would not be living in Findon but would choose to live in Portlethen or Hillside where all these amenities are readily available.

Why are these houses proposed for Findon when there is plenty land available for building in Hillside? I was also of the belief that previous plans did not allow any building to be done East of the railway line?!

I look forward to hearing back from you and that this proposal is removed from the Local Development Plan 2020.
