PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I refer to Aberdeen City LDP for OP46, bid 1308 which is for Royal Devenick Park. Part of this land is within this bid is within the City and part is within the Shire. Access to the proposed development is from Causewaymount Road and a proposed access from A92. This is not shown on the Shire LDP for 2020. The applicant has also previously made application to the Shire for a very large scale development, and the application to the City could be seen as a lever to support a future application to the Shire. Including the current City proposal and its removal of Shire green belt in the proposed Shire LDP would provide transparency of the impact of the City development.

Reason for change:

My reason for submitting this response on the plan is to raise my concerns around this proposed development.

My specific concerns are as follows. All relate to the impact on the Shire, specifically Causewaymouth Road.

1. Removal of green belt land. The proposal to the City could provide future justification for a further submission of the earlier application to the Shire.
2. The application to the City requires access from Causewaymount Road. If the development goes ahead with around 150 homes it is not unreasonable to assume this will also bring around 300 cars. This road is not suitable for the additional road traffic. I frequently walk along this road and even with the current level of traffic there is an element of risk as the road is very narrow with a number of blind bends and there are no pavements. Cars and vans pass within 1-2 metres of pedestrians at speeds up to 50-60 mph.
3. Causewaymount will be the preferred traffic route to Portlethen from the development.
4. This will lead to a reduction of walkers, runners, cyclists etc using this road and subsequent loss of access to (currently) safe and quiet countryside.
5. Lack of Public Transport. The application states that a bus service is available from Kincorth. I have lived in Deeside Brae for 7 years and haven't used that service once. Crossing A92 and going into a housing estate isn't an obvious thing to do to catch a bus in any case. The Stagecoach bus service between the city and Portlethen /Stonehaven is an option but my experience is that it is fairly infrequent and also the location of the current bus stops would not be hugely beneficial to the proposed development. This will lead to the car being the preferred mode of transport for residents.
