PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

I would like to say how pleased I was to learn that the Shire Council had rejected the 'Royal Devenick Park' proposal which would have devastated a very beautiful, historic and well used area. I am very happy that this unique landscape is to stay as it is.

I was very concerned to then learn of the proposed **proposed** proposal, which again would be destroying designated green belt land. I find it astonishing that the Council can, with ease it seems, re-zone green belt land to be 'residential', in this case (OP46, bid 1308 'Leggart Brae') following an amendment proposed by Councillor **and the Planning** Officers' recommendation of the site as undesirable. This rather undermines the designation of green-belt land in the first place. 'Green belt' is supposed to protect natural, wild areas from development and to protect the wildlife that lives there.

My other concern is access to the site while a build is ongoing and the access for new residents to the site. The Causeymounth road is narrow and steep with sharp bends. It is quite a fast road but is also used by many pedal bikers and walkers. Heavy construction vehicles on this small road would be highly dangerous and not suitable for major traffic. Furthermore the road is unlit and has no road markings. The Causeymounth road is a 12th century drover's road and a designated Heritage Path. If there are to be 150 new houses there would be *at least* 150 more cars travelling on this road which is unacceptable, would cause congestion and the road will suffer deterioration. I am also alarmed at the mention of a proposed link road from the site onto the B9077/South Deeside Road. It seems that this would again cut through greenbelt land and destroy woodland and forest tree planting undertaken by the Forestry Commission in recent years. Also in the 'NESBReC 'Notable Species Search' bats, badgers, red squirrel, otter and numerous birds were identified as living in and around the proposed development area. Roe deer are also known to move in family groups from the Den of Leggart Woodland across the Causeymounth road into the Tollohill Braes

The Shire LDP includes policies on Natural Heritage and Landscape – Section 10 Policy E1 Natural Heritage Nature Conservation Sites E1.1:

"We will not allow new developments where it may have an unacceptable adverse effect on a nature conservation site designated for its biodiversity or geodiversity importance....."

Both the building of houses on greenbelt land and using the Causeymounth road as an access point seems to completely violate the above policy and any development on this site would seriously affect the sensitive habitat and wildlife in the area.

I sincerely hope that the Shire Council again use their robust policies, written to protect natural, wild, greenbelt areas, to reject this proposal.
