



PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the OP3 allocation from the Kincardine O'Neil settlement statement in its entirety and from Table 3 of Appendix 6. Identify an alternative effective allocation in the Local Growth Area of the Rural HMA to assist in meeting the strategic allowances. If Marketability constraints preclude the identification of an alternative effective allocation in the Rural HMA, identify a replacement allocation in the Local Growth Area of the adjacent Aberdeen HMA where marketability constraints are not an issue.

Reason for change:

This allocation came into the housing land audit in 2006 and is ownership constrained in the 2019 housing land audit. It is also included in the schedule of long term constrained sites with the note that it will be promoted once (the) market improves.

There is another allocation in the settlement that commenced construction in 2016 and has by the end of 2018 completed 20 houses. The assertion that there are adverse market conditions in this location is completely false as evidenced by the fact that the site is ownership and not marketability constrained.

The site has been an allocation in the past three Local Plans without delivering any housing or so much as a planning application. There is no rational justification for entering this site into a fourth successive local development plan given the failure of the owner to adequately promote development over the past 15 years and no basis to support the confidence that it will deliver housing necessary to satisfy SPP.
