

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

## RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.


Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the contribution of 10 houses to the Strategic Growth Area allowances from the OP1 allocation in Old Rayne. Identify an alternative new effective allocation in the Huntly to Pitcaple Strategic Growth Area or in any other Strategic Growth Area if marketability constraint preclude that possibility.

#### Reason for change:

The OP1 allocation entered the housing land audit in 2006 and is currently entered in the 2019 audit as a long terms constrained site on physical and marketability grounds. The timescale for the removal of the constraint is given as unknown.

An application to develop the site was lodged in 2010 and withdrawn in May 2011. It is evident from the site layout plan annexed to that application that the physical constraint possibly relates to the inadequacies of the existing road that would give access to the site. It is extremely narrow and it is unlikely that improvements could be made between the proposed site entrance and Lawrence Road without requiring land in a different ownership.

A long term constrained site with a physical constraint, no planning consent and no noted housebuilder interest provides no basis for the confidence necessary to satisfy SPP that the site can become effective during the plan period. It is inappropriate and unjustifiable to score the capacity of this site against meeting the strategic allowances.
