PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the contribution of 38 houses from the OP1 allocation in Oldmeldrum to meeting the strategic allowances in the Local Growth Area of the Aberdeen HMA and reduce the LDP 2021 allocation to 50 houses, (Table 2, Appendix 6). Identify a new allocation with a capacity of 38 houses to meet the strategic allowance in the Formartine part of the Local Growth Area of the Aberdeen Housing Market Area.

Reason for change:

This allocation entered the audit in 2013. It was effective in the 2019 Housing Land Audit with a capacity of 50 houses. It was subject of an application for 62 houses which was withdrawn in 2016. The application reference APP 2019/1555 mentioned in the allocation statement is for 37 houses and 12 affordable houses. The total development pending approval is for 49 houses which can be serviced by a single access from the neighbouring public highway. A higher density development cannot be serviced in this location due to the lack of an adequate second vehicular access point.

Given the substantial shortfall in allocations necessary to satisfy the provisions of paragraph 110 of SPP (See Primary representation on Housing Land Supply in the Aberdeen HMA) it is essential that site capacities are not artificially inflated merely to 'make up the numbers.'
