# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

Delete all references to the OP4 allocation in Alford from Table 3, Appendix 6 and the Alford settlement statement. Identify an alternative effective allocation in the Local Growth Area of the LDP or, if marketability constraints preclude the identification of such an allocation, in the Local Growth Area of the adjacent Aberdeen HMA

## Reason for change:

This allocation came into the housing land audit in 2004. A planning application for 250 houses for development to the North and South of Greystone Road was approved on the 14th July 2010 under reference APP/2005/2835. The approved masterplan for the development indicated four phases. The first three phases of the development are now presented in the emerging LDP as the OP3 allocation of 259 homes. The 2019 housing land audit indicates that the residual capacity of the OP3 site is just 97 homes. (A separate representation seeks to correct the overstatement).

The fourth phase of the development is the OP4 site which is constrained on physical grounds. While it formed part of the consent for 250 houses granted in 2010 the nature of the constraint has been known to the Planning Authority since at least the 30th January 2009 when the Authority's Roads Department issued a drawing detailing the roads options to overcome the physical constraint to the development of this allocation.

None of the technical options favoured the upgrading of Kingsford Road and it is perplexing to see such a suggestion being promoted in the emerging LDP. The difficulty in contemplating such a resolution to the problem is that the road is narrow and constricted by third party ownerships on each side of the road. The additional constraint is that visibility splays at the junction of Kingsford Road are difficult if not impossible to achieve due to gradient and alignment. The pinch point in all proposal that seek to use Greystone Road or Kingsford road is the junction between Greystone Road and Main Street. The configuration of this junction is simply incapable of safely accommodating the traffic flows from a substantial residential development. The housing allocation and the new school campus have been served by the adoption of Option 2 which comprises a new relief road onto the A944 at the western end of the settlement. The site should be deleted from the emerging LDP on the basis that more than sufficient attempts have been made to resolve the access constraint without success. The provisions of SPP would be hopelessly contravened by the retention of this site in the LDP.
