PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Delete the OP1 allocation in Memsie (Table 3 - Housing Allocations in the Rural HMA. Allocate an alternative site that is either effective or capable of becoming effective in the Local Growth Area of the RHMA or, if marketability constraints preclude the identification of an alternative allocation, relocate allocation to the Local Growth Area of the adjacent Aberdeen HMA where marketability constraints are not an issue

Reason for change:

The OP1 allocation came into the housing land audit in 2013 with a capacity of 15 houses. On the 1st January 2019 it was constrained on grounds of ownership and marketability.

During the eight years the site has been in the audit it has attracted no developer interest and no planning applications have been lodged. As of the 1st January 2019 the site was not anticipated to deliver any houses until the post 2026 period and nothing has changed subsequently to alter that expectation. There is no basis therefore to support the confidence necessary to satisfy SPP that this site will deliver housing within the LDP plan period.

The OP2 site in Memsie continues an established pattern of growth to the north of the settlement and is promoted by an established local housebuilder. It has the benefit of a resolution to the drainage issue in the settlement which is not available to the OP1 site. Private soakaways are acknowledged to have failed in this settlement due to adverse ground conditions and the OP1 allocation.

The utilisation of existing constrained sites to contribute to meeting the strategic allowances is unacceptable and demonstrates a reprehensible disregard for the provisions of SPP which seek to ensure that all allocations are effective or that there is a genuine basis to support the allocation becoming effective within the plan period.
