



# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete reference to OP3 allocation in Luthermuir from Settlement statement (pages 706 and 707) and from Table 3, Appendix 6. Identify replacement effective allocation in the Rural HMA or, if marketability constraints preclude the identification of such an alternative allocation, in the Local Growth Area of the Aberdeen HMA where no marketability issues exist.

## Reason for change:

The OP3 site is landlocked and separated from Church road by properties in third party ownership as acknowledged in the statement relating to the allocation. It is not readily accessible in terms of the provision of an adequate pedestrian and vehicular access. Any potential developer would be unable to demonstrate that the required visibility splays at a new entrance onto Church Road were in the same ownership and control as the proposed allocation. The Roads Authority would oppose the grant of consent in such circumstances.

In the 2019 housing land audit there are three allocations in Luthermuir each with a capacity of 25 houses. Two sites are classed as marketability constrained. The deletion of one of these existing allocations with a new allocation which has a physical constraint does not remove the marketability constraint where excessive allocations have been incompetently directed to a small rural settlement.
