



# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

Delete the reference to the Longhaven OP1 allocation from Table 3 of Appendix 6 in its entirety and remove the reference to the allocation from the settlement statement (page 312 and 313)

## Reason for change:

This allocation entered the audit in 2011 and is marketability constrained in the 2019 Housing Land Audit. It has not attracted developer interest or a planning application in the past decade. It has failed to deliver any housing in the previous LDPs.

The site is separated from the A90 trunk road by existing development and according to the settlement statement access is to be taken via the existing track that links Longhaven with the farms to the north. On closer scrutiny, this proposed arrangement is not technically feasible because the width of the existing access track is constrained by property boundaries and a house extension between the edge of the allocation and the junction of the track with the A90(T). Additionally, a developer would not be able to demonstrate to the satisfaction of the Roads Authority that adequate visibility splays at the junction of the track and the extremely busy A90(T) were capable of being delivered and maintained because these would be in third party ownership.

The settlement also lacks any public sewerage facilities or WWTP.

Any competent assessment of this proposed allocation would conclude that it is incapable of delivering 30 houses and that there is no basis to support the necessary confidence that it will become effective required to satisfy the provisions of SPP.
