



PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Correct the entries shown in Table 3 of Appendix 6 in respect of the OP3 allocation in Alford to 259 (LDP 2017 allocation), Built by Jan 2019 - 162, Effective 2019 - 97, LDP 2021 allocation - 97 to accurately reflect the position detailed in the 2019 housing land audit.

Reason for change:

The LDP is based to the 1st January 2019 and all allocations that are being taken forward into the emerging plan should accurately indicate their residual capacity as detailed in the 2019 housing land audit to avoid the misconception that there is a greater than actual landbank. This allocation is an amalgamation of earlier allocations in the settlement.
