PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reduce the capacity of the LDP 2021 allocation in respect of the OP1 allocation in Fraserburgh from 600 houses to 395 houses, (Table 3 : Housing Allocations in the Rural HMA)

Reason for change:

The OP1 site had a residual capacity of 575 houses out of a total capacity of 600 houses according to the 2019 housing land audit.

The audit advises that by the end of 2026 a further 175 houses are anticipated to be completed leaving an anticipated residual supply at the beginning of 2017 of 400 houses.

At the anticipated annual completion rate of 20 houses per annum the site is likely to be completed by the end of 2046 which is well outside the first plan period.

On the basis of the 2019 housing land audit, the number of houses on this site that are likely to be completed between 1st January 2019 and the 31st December 2037 (2032 + five years) is 395 houses and this should be reflected in Table 3 to avoid a substantial overstatement of the contribution this allocation will make to the delivery of housing within the lifetime of the LDP.
