PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Deleted the reference to the OP2 allocation in Auchnagatt. (Table 3: Housing allocations in the Rural HMA) and in the settlement statement for Auchnagatt.

Reason for change:

This allocation entered the housing land audit in 1995 and is logged as a long term constrained site in the Schedule annexed to the 2019 Housing Land Audit.

There is no waste water treatment plant in Auchnagatt hence the infrastructure constraint and no known timescale for the removal of that constraint and no catalyst in the form of any development pressure to resolve that uncertainty.

During previous annual housing land audit discussions there has been reference made to a land ownership issue which precludes development unless it is resolved hence the ownership constraint.

In the past 26 years the site has attracted a single planning application for 4 houses which was lodged in 2004 and subsequently approved on the 6th July 2007. The consent lapsed without development being commenced. It is highly questionable whether any demand in the locality of Auchnagatt would justify an allocation of this scale.

Promoting long term constrained sites as allocations in an emerging local development plan should not be acceptable as it inflates the established supply and may be used as an excuse by the Planning Authority to avoid delivering an adequate and effective housing land supply.
