



PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Delete the OP1 allocation in Hatton (of Cruden) from Table 3: Housing Land Allocations in the Rural HMA of Appendix 6 and from the settlement statement (pages 309 and 310)

Reason for change:

This allocation entered the audit in 2014 and was constrained in the 2019 audit on marketability and ownership grounds. It has failed to attract developer interest or a planning application in the past 7 years.

On close scrutiny, the allocation is unlikely to be deliverable for a number of technical reasons. Firstly, the access from Main Street is via a narrow farm track. Secondly, the allocation, itself has no frontage onto that track being separated from it by an elongated strip of field.

The proposed allocation is at the western extremity of the settlement whereas the WWTP is located to the east of the settlement. It is considered highly unlikely that this site could be economically serviced by the existing public waste water system. On that basis, a competent assessment of the deliverability of houses in this location would conclude that the site should not be taken forward into the next LDP. There is no basis to support the confidence that this site can or will deliver housing necessary to satisfy SPP.
